Mr. MURPHY (for himself and Mr. GUTHRIE) introduced the following bill; which was referred to the Committee on Energy and Commerce, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To amend the Public Health Service Act with respect to the determination, termination, and renewal of public health emergencies, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “PHE Congressional
5 Review Act”.

1 **SEC. 2. PUBLIC HEALTH EMERGENCIES.**

2 Subsection (a) of section 319 of the Public Health
3 Service Act (42 U.S.C. 247d) is amended to read as fol-
4 lows:

5 “(a) EMERGENCIES.—

6 “(1) IN GENERAL.—If the Secretary deter-
7 mines, after consultation with such public health of-
8 ficials as may be necessary, that—

9 “(A) a disease or disorder presents a pub-
10 lic health emergency; or

11 “(B) a public health emergency, including
12 significant outbreaks of infectious diseases or
13 bioterrorist attacks, otherwise exists,

14 the Secretary may take such action as may be ap-
15 propriate to respond to the public health emergency,
16 including making grants, providing awards for ex-
17 penses, and entering into contracts and conducting
18 and supporting investigations into the cause, treat-
19 ment, or prevention of a disease or disorder as de-
20 scribed in subparagraphs (A) and (B).

21 “(2) CONGRESSIONAL REVIEW OF NATIONWIDE
22 EMERGENCIES.—Not later than 6 months after the
23 date on which a determination of a nationwide pub-
24 lic health emergency is made, and every 6 months
25 thereafter until the termination of such nationwide
26 public health emergency, each House of Congress

1 shall meet to consider a vote on a joint resolution to
2 determine whether that emergency shall be termi-
3 nated.

4 “(3) DURATION.—

5 “(A) TERMINATION.—Any determination
6 of a public health emergency under paragraph

7 (1) terminates upon the earlier of—

8 “(i) the Secretary declaring that the
9 emergency no longer exists;

10 “(ii) the expiration of the 90-day pe-
11 riod beginning on the date on which the
12 determination is made by the Secretary; or

13 “(iii) upon the enactment of a joint
14 resolution to terminate the emergency.

15 “(B) RENEWAL.—Determinations that ter-
16 minate under clause (i) or (ii) of subparagraph
17 (A) may be renewed by the Secretary (on the
18 basis of the same or additional facts), and sub-
19 paragraph (A) applies to each such renewal.

20 “(C) NOTIFICATION TO CONGRESS OF RE-
21 NEWAL.—Not later than 48 hours after making
22 a determination under this subsection of a pub-
23 lic health emergency (including a renewal), the

1 Secretary shall submit to the Congress written
2 notification of the determination.”.
