# **A BILL**

To provide that the Federal Reports Elimination and Sunset Act of 1995 does not apply to certain reports required to be submitted by the Tennessee Valley Authority, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Tennessee Valley Author-*  
5 *ity Salary Transparency Act”.*

6 **SEC. 2. SALARY DISCLOSURE; EXCEPTION TO REPORT**  
7 **ELIMINATION.**

8 *Section 9 of the Tennessee Valley Authority Act of 1933*  
9 *(16 U.S.C. 831h) is amended—*

10 *(1) in subsection (a), by striking “a financial*  
11 *statement” and all that follows through “\$1,500 a*  
12 *year” and inserting “a report of the total number of*  
13 *employees at the management level or above, to in-*  
14 *clude all executives and board members, that shall in-*  
15 *clude the names, salaries, and duties of such employ-*  
16 *ees, that are receiving compensation at or greater*  
17 *than the maximum rate of basic pay for grade GS-*  
18 *15 of the General Schedule”;*

19 *(2) by striking all that precedes “The Board*  
20 *shall” and inserting the following:*

21 **“SEC. 9. FINANCIAL REPORTING.**

22 *“(a) REPORT ON COMPENSATION.—*

23 *“(1) IN GENERAL.—”; and*

24 *(3) in subsection (a), by adding at the end the*  
25 *following:*

1           “(2) *EXEMPTION.*—*The information concerning*  
2           *salaries of employees of the Corporation contained in,*  
3           *or filed with, the report described in paragraph (1)*  
4           *is exempt from—*

5                     “(A) *disclosure under section 552(b)(3) of*  
6                     *title 5, United States Code; and*

7                     “(B) *the requirements of the Access to Con-*  
8                     *gressionally Mandated Reports Act (Public Law*  
9                     *117–263).*”.
