Mr. KILDEE introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To provide for technical assistance under the health profession opportunity grant program under section 2008 of the Social Security Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Technical Assistance
5 for Health Grants Act”.

6 **SEC. 2. TECHNICAL ASSISTANCE.**

7 (a) IN GENERAL.—Section 2008 of the Social Secu-
8 rity Act (42 U.S.C. 1397) is amended—

9 (1) in subsection (b)(4), by striking subpara-
10 graph (D); and

1 (2) by redesignating subsections (c) and (d) as
2 subsections (d) and (e) and inserting after sub-
3 section (b) the following:

4 “(c) TECHNICAL ASSISTANCE.—

5 “(1) IN GENERAL.—The Secretary shall provide
6 technical assistance—

7 “(A) to assist eligible entities in applying
8 for grants under this section;

9 “(B) that is tailored to meet the needs of
10 grantees at each stage of the administration of
11 projects for which grants are made under this
12 section;

13 “(C) that is tailored to meet the specific
14 needs of Indian tribes, tribal organizations, and
15 tribal colleges and universities;

16 “(D) that is tailored to meet the specific
17 needs of the territories;

18 “(E) that is tailored to meet the specific
19 needs of eligible entities in carrying out dem-
20 onstration projects for which a grant is made
21 under this section; and

22 “(F) to facilitate the exchange of informa-
23 tion among eligible entities regarding best prac-
24 tices and promising practices used in the
25 projects.

1 “(2) PEER TECHNICAL ASSISTANCE CON-
2 FERENCES.—The Secretary shall hold peer technical
3 assistance conferences for entities to which a grant
4 is made under this section.

5 “(3) REPORT TO THE CONGRESS.—During each
6 Congress, the Secretary shall submit to the Com-
7 mittee on Ways and Means of the House of Rep-
8 resentatives and the Committee on Finance of the
9 Senate a report on the nature of any technical as-
10 sistance provided to grantees under this section.”.

11 (b) FUNDING.—Section 2008(c)(1) of such Act (42
12 U.S.C. 1397(c)(1)) is amended by inserting “, and to
13 carry out subsection (c) \$15,000,000 for fiscal year 2024”
14 before the period.

15 **SEC. 3. EFFECTIVE DATE.**

16 The amendments made by this Act shall take effect
17 on October 1, 2023.
