## A BILL

To require the Administrator of the Federal Aviation Administration to submit to Congress progress reports on the development and implementation of a national plan to transition to the use of a fluorine-free firefighting foam, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Save Our Airports Re-  
5       porting Act”.

1     **SEC. 2. PROGRESS REPORTS ON THE NATIONAL TRANSI-**  
2                 **TION PLAN RELATED TO A FLUORINE-FREE**  
3                 **FIREFIGHTING FOAM.**

4         (a) IN GENERAL.—Not later than 180 days after the  
5     date of enactment of this section, and every 180 days  
6     thereafter until the progress report termination date de-  
7     scribed in subsection (c), the Administrator of the Federal  
8     Aviation Administration, in consultation with the Adminis-  
9     trator of the Environmental Protection Agency and the  
10   Secretary of Defense, shall submit to the appropriate com-  
11   mittees of Congress a progress report on the development  
12   and implementation of a national transition plan related  
13   to a fluorine-free firefighting foam that meets the per-  
14   formance standards referenced in chapter 6 of AC No:  
15   150/5210–6D and is acceptable under section 139.319(l)  
16   of title 14, Code of Federal Regulations, for use at part  
17   139 airports.

18         (b) REQUIRED INFORMATION.—Each progress report  
19     required under subsection (a) shall include the following:

20                 (1) An assessment of the progress made by the  
21     Administrator of the Federal Aviation Administra-  
22     tion with respect to providing part 139 airports  
23     with—

24                     (A) guidance from the Environmental Pro-  
25     tection Agency on acceptable environmental lim-

1           its relating to such fluorine-free firefighting  
2           foam;

3           (B) guidance from the Department of De-  
4           fense on the transition to a fluorine-free fire-  
5           fighting foam by the Department;

6           (C) best practices for the decontamination  
7           of existing aircraft rescue and firefighting vehi-  
8           cles, systems, and other equipment used to de-  
9           ploy firefighting foam at part 139 airports; and

10          (D) timelines for the release of policy and  
11          guidance relating to part 139 airport implemen-  
12          tation plans for obtaining approved military  
13          specification products and firefighting personnel  
14          training.

15          (2) An assessment of the progress made by the  
16          Administrator with respect to providing airports that  
17          are not part 139 airports and local authorities with  
18          responsibility for inspection and oversight with guid-  
19          ance described in subparagraphs (A) and (B) of  
20          paragraph (1) as it relates to the use of fluorine-free  
21          firefighting foam at such airports.

22          (3) Such other information as the Adminis-  
23          trator determines appropriate.

24          (c) PROGRESS REPORT TERMINATION DATE.—For  
25          purposes of subsection (a), the progress report termi-

1 nation date described in this subsection is the date on  
2 which the Administrator notifies the appropriate commit-  
3 tees of Congress that development and implementation of  
4 the national transition plan described in subsection (a) is  
5 complete.

6 (d) DEFINITIONS.—In this section:

7 (1) APPROPRIATE COMMITTEES OF CON-  
8 GRESS.—The term “appropriate committees of Con-  
9 gress” means—

10 (A) the Committees on Transportation and  
11 Infrastructure, Energy and Commerce, and  
12 Armed Services of the House of Representa-  
13 tives; and

14 (B) the Committees on Commerce, Science,  
15 and Transportation, Environment and Public  
16 Works, and Armed Services of the Senate.

17 (2) PART 139 AIRPORT.—The term “part 139  
18 airport” means an airport certified under part 139  
19 of title 14, Code of Federal Regulations.
