2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION.**

4 The United States courthouse located at 350 W. 1st
5 Street, Los Angeles, California, shall be known and des-
6 ignated as the “Felicitas and Gonzalo Mendez United
7 States Courthouse”.

8 **SEC. 2. REFERENCES.**

9 Any reference in a law, map, regulation, document,
10 paper, or other record of the United States to the United
11 States courthouse referred to in section 2 shall be deemed
12 to be a reference to the “Felicitas and Gonzalo Mendez
13 United States Courthouse”.
