A BILL

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Protecting Our Nation’s*
 5 *Capital Emergency Act of 2024”.*

6 **SEC. 2. RESTORATION OF EQUITABLE AND FAIR TREAT-**
 7 **MENT OF LAW ENFORCEMENT PERSONNEL OF**
 8 **DISTRICT OF COLUMBIA.**

9 *(a) RESTORATION OF RIGHT TO NEGOTIATE MATTERS*
 10 *PERTAINING TO DISCIPLINE OF DISTRICT OF COLUMBIA*
 11 *LAW ENFORCEMENT OFFICERS THROUGH COLLECTIVE*
 12 *BARGAINING.—Section 1708 of the District of Columbia*

18 *(b) RESTORATION OF STATUTE OF LIMITATIONS FOR*
 19 *CLAIMS AGAINST MEMBERS OR CIVILIAN EMPLOYEES OF*
 20 *METROPOLITAN POLICE DEPARTMENT.—Subtitle M of title*
 21 *I of the Comprehensive Policing and Justice Reform*
 22 *Amendment Act of 2022 (D.C. Law 24–345) is repealed,*
 23 *and any provision of law amended or repealed by such sub-*
 24 *title is restored or revived as if such subtitle had not been*
 25 *enacted into law.*
