AN ACT

To designate the checkpoint of the United States Border
Patrol located on United States Highway 90 West in
Uvalde County, Texas, as the “James R. Dominguez
Border Patrol Checkpoint”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “James R. Dominguez
5 Memorial Act of 2023”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) A native of San Antonio, Texas, Border Pa-
2 trol Agent James R. Dominguez—

3 (A) proudly and honorably served his coun-
4 try as an agent of the U.S. Border Patrol for
5 more than 12 years;

6 (B) began his service with the U.S. Border
7 Patrol in 2000; and

8 (C) graduated as part of the 434th session
9 of the Border Patrol Academy.

10 (2) Agent Dominguez served at the Uvalde Sta-
11 tion in the Del Rio Sector.

12 (3) On July 19, 2012, Agent Dominguez
13 stopped to clear debris from the roadway that posed
14 risks to road and community safety along Highway
15 90 near Cline, Texas. While on scene, Agent
16 Dominguez was struck and killed by a passing vehi-
17 cle.

18 (4) Agent Dominguez is survived by his wife
19 and 4 children.

20 **SEC. 3. DESIGNATION.**

21 The checkpoint of the United States Border Patrol
22 located on United States Highway 90 West in Uvalde
23 County, Texas, shall be known and designated as the
24 “James R. Dominguez Border Patrol Checkpoint”.

1 **SEC. 4. REFERENCES.**

2 Any reference in a law, map, regulation, document,
3 paper, or other record of the United States to the check-
4 point described in section 3 shall be deemed to be a ref-
5 erence to the “James R. Dominguez Border Patrol Check-
6 point”.
