# A BILL

To direct the Secretary of the Interior and the Secretary of Agriculture to notify applicants of the completion status of right-of-way applications under section 501 of the Federal Land Policy and Management Act of 1976 and section 28 of the Mineral Leasing Act.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*  
3   **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Right-Of-Way Applica-*  
5   *tion Transparency and Accountability Act” or the*  
6   *“ROWATA Act”.*

7   **SEC. 2. DETERMINATION REGARDING RIGHTS-OF-WAY.**

8       (a) *NOTICE.—Not later than 90 days after the Sec-*  
9   *retary concerned receives an application to grant a right-*  
10   *of-way, the Secretary concerned shall—*

11           (1) *notify the applicant as to whether the appli-*  
12   *cation is complete; or*

13           (2) *notify the applicant that information is*  
14   *missing and specify any information that is required*  
15   *to be submitted for the application to be complete.*

16       (b) *DEFINITIONS.—In this Act:*

17           (1) *RIGHT-OF-WAY.—The term “right-of-way”*  
18   *means—*

19           (A) *a right-of-way issued, granted, or re-*  
20   *newed under section 501 of the Federal Land*  
21   *Policy and Management Act of 1976 (43 U.S.C.*  
22   *1761); or*

23           (B) *a right-of-way granted under section 28*  
24   *of the Mineral Leasing Act (30 U.S.C. 185).*

- 1                   (2) *SECRETARY CONCERNED.*—The term “Sec-  
2                   retary concerned” means—  
3                   (A) with respect to public lands, the Sec-  
4                   retary of the Interior; and  
5                   (B) with respect to National Forest System  
6                   lands, the Secretary of Agriculture.
