A BILL

To amend the Immigration and Nationality Act to provide that aliens who have been convicted of or who have committed Social Security fraud are inadmissible and deportable.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Consequences for Social*
5 *Security Fraud Act”.*

6 **SEC. 2. INADMISSIBILITY AND DEPORTABILITY RELATED**
7 **TO SOCIAL SECURITY FRAUD OR IDENTIFICA-**
8 **TION DOCUMENT FRAUD.**

9 *(a) INADMISSIBILITY.—Section 212(a)(2) of the Immi-*
10 *gration and Nationality Act (8 U.S.C. 1182(a)(2)) is*
11 *amended by adding at the end the following:*

12 “*(J) SOCIAL SECURITY FRAUD OR IDENTI-*
13 **FICATION DOCUMENT FRAUD.—Any alien who**
14 *has been convicted of, who admits having com-*
15 *mitted, or who admits committing acts which*
16 *constitute the essential elements of an offense*
17 *under section 208 of the Social Security Act (42*
18 *U.S.C. 408) (relating to social security account*
19 *numbers or social security cards), an offense*
20 *under section 1028 of title 18, United States*
21 *Code (relating to fraud and related activity in*
22 *connection with identification documents, au-*
23 *thentication features, and information), or a*
24 *conspiracy to commit such an offense, is inad-*
25 *missible.”.*

1 (b) *DEPORTABILITY.*—Section 237(a)(2) of the Immigrant
2 and Nationality Act (8 U.S.C. 1227(a)(2)) is
3 amended by adding at the end the following:

4 “(G) SOCIAL SECURITY FRAUD OR IDENTI-
5 FICATION DOCUMENT FRAUD.—Any alien who
6 has been convicted of, who admits having com-
7 mitted, or who admits committing acts which
8 constitute the essential elements of an offense
9 under section 208 of the Social Security Act (42
10 U.S.C. 408) (relating to social security account
11 numbers or social security cards), an offense
12 under section 1028 of title 18, United States
13 Code (relating to fraud and related activity in
14 connection with identification documents, au-
15 thentication features, and information), or a
16 conspiracy to commit such an offense, is deport-
17 able.”.
