A BILL

To prohibit the availability of Federal education funds for elementary and secondary schools that receive direct or indirect support from the Government of the People's Republic of China.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Promoting Responsible*
5 *Oversight To Eliminate Communist Teachings for Our*
6 *Kids Act” or the “PROTECT Our Kids Act”.*

7 **SEC. 2. PROHIBITION ON AVAILABILITY OF FUNDS.**

8 (a) *PROHIBITION.—Notwithstanding any other provi-*
9 *sion of law, no funds may be made available under an ap-*
10 *plicable program to any elementary school or secondary*
11 *school that—*

12 (1) *has a partnership in effect with a cultural or*
13 *language institute directly or indirectly funded by the*
14 *Government of the People’s Republic of China, includ-*
15 *ing a Confucius Institute;*

16 (2) *operates a learning center directly or indi-*
17 *rectly supported by the Government of the People’s*
18 *Republic of China (commonly referred to as a “Con-*
19 *fucius Classroom”); or*

20 (3) *otherwise receives support from an indi-*
21 *vidual or entity acting directly or indirectly on behalf*
22 *of the Government of the People’s Republic of China,*
23 *including support in the form of teaching materials,*
24 *personnel, funds, or other resources.*

1 (b) *EFFECTIVE DATE.*—*The prohibition under sub-*
2 *section (a) shall take effect on the date that is one year after*
3 *the date of the enactment of this Act.*

4 (c) *CONTRACTS MADE PRIOR TO DATE OF ENACT-*
5 *MENT.*—

6 (1) *IN GENERAL.*—

7 (A) *WAIVER REQUEST SUBMISSION.*—*In the*
8 *case of an elementary school or a secondary*
9 *school that is a party to a contract described in*
10 *paragraph (2), the school timely shall submit to*
11 *the Secretary a request for a waiver of the prohi-*
12 *bition under subsection (a) that includes—*

13 (i) *the complete and unredacted text of*
14 *the contract, and if the contract is not in*
15 *English, a translated copy of the text into*
16 *English; and*

17 (ii) *a statement demonstrating that the*
18 *contract is for the benefit of the school's*
19 *mission and students and will promote the*
20 *security, stability, and economic vitality of*
21 *the United States.*

22 (B) *WAIVER ISSUANCE.*—*the Secretary,*
23 *upon receipt of a request submitted under sub-*
24 *paragraph (A), may issue a waiver to the school*
25 *for a period beginning on the effective date speci-*

1 fied in subsection (b) and ending the date on
2 which the contract terminates.

3 (2) *CONTRACTS DESCRIBED.*—A contract is de-
4 scribed in this paragraph if the contract—

5 (A) takes effect before the date of the enact-
6 ment of this Act;

7 (B) continues to be effective after the effec-
8 tive date specified in subsection (b); and

9 (C) relates to at least one of the cir-
10 cumstances described in paragraph (1), (2), or
11 (3) of subsection (a).

12 (d) *NOTICE TO AFFECTED SCHOOLS.*—Not later than
13 90 days after the date of the enactment of this Act, the Sec-
14 retary shall provide notice to elementary and secondary
15 schools of the requirements of this section together with
16 guidance for achieving compliance with such requirements.

17 (e) *DEFINITIONS.*—In this section:

18 (1) *APPLICABLE PROGRAM.*—The term “applica-
19 ble program” has the meaning given that term in sec-
20 tion 400(c)(1) of the General Education Provisions
21 Act (20 U.S.C. 1221(c)(1)).

22 (2) *ESEA TERMS.*—The terms “elementary
23 school”, “secondary school”, and “Secretary” have the
24 meanings given those terms in section 8101 of the El-

1 *ementary and Secondary Education Act of 1965 (20*
2 *U.S.C. 7801).*
