A BILL

To amend title 46, United States Code, to require a State to enter into a data sharing agreement with the Secretary of Homeland Security and the Secretary of Transportation in order to be eligible for the port security grant program and the port infrastructure development program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “States Helping Appre-
3 hend Rogue Exports Act”.

4 **SEC. 2. STATE DEPARTMENT OF MOTOR VEHICLE DATA**
5 **SHARING AGREEMENTS.**

6 (a) PORT INFRASTRUCTURE DEVELOPMENT PRO-
7 GRAM.—Section 54301(a)(5) of title 46, United States
8 Code, is amended by adding at the end the following:

9 “(C) STATE DEPARTMENT OF MOTOR VE-
10 HICLE DATA SHARING AGREEMENTS.—To be el-
11 igible for a grant under this subsection or sub-
12 section (b), the State or States with respect to
13 which a grant is being provided shall have in ef-
14 fect a data sharing agreement that requires the
15 State or States to provide, upon request of the
16 Secretary of Homeland Security or the Sec-
17 retary of Transportation, identifying informa-
18 tion regarding any motor vehicle registered in
19 the State, including registration, title, and vehi-
20 cle identification number.”.

21 (b) PORT SECURITY GRANT PROGRAM.—Section
22 70107(i) of title 46, United States Code, is amended by
23 adding at the end the following:

24 “(5) STATE DEPARTMENT OF MOTOR VEHICLE
25 DATA SHARING AGREEMENTS.—To be eligible for a
26 grant under this section, the State in which the enti-

1 ty subject to an Area Maritime Transportation Secu-
2 rity Plan is located shall have in effect a data shar-
3 ing agreement that requires the State to provide,
4 upon request of the Secretary of Homeland Security
5 or the Secretary of Transportation, identifying infor-
6 mation regarding any motor vehicle registered in the
7 State, including registration, title, and vehicle identi-
8 fication number.”.

9 (c) AIRPORT IMPROVEMENT PROGRAM.—Section
10 47106(a) of title 49, United States Code, is amended—

11 (1) in paragraph (6)(E) by striking “and” at
12 the end;

13 (2) in paragraph (7)(D) by striking the period
14 at the end and inserting “; and”; and

15 (3) by adding at the end the following:

16 “(8) the State in which the project is located
17 has in effect a data sharing agreement with the Sec-
18 retary of Homeland Security and the Secretary of
19 Transportation that requires the State to provide,
20 upon request of either such Secretary, identifying in-
21 formation regarding any motor vehicle registered in
22 the State, including registration, title, and vehicle
23 identification number.”.
