A BILL

To amend title XIX of the Social Security Act to further require certain additional provider screening under the Medicaid program.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MEDICAID PROVIDER SCREENING REQUIRE-**
 4 **MENTS.**

5 *Section 1902(kk)(1) of the Social Security Act (42*
 6 *U.S.C. 1396a(kk)(1)) is amended—*

7 *(1) by striking “The State” and inserting:*

8 *“(A) IN GENERAL.—The State”; and*

9 *(2) by adding at the end the following new sub-*
 10 *paragraph:*

11 *“(B) ADDITIONAL PROVIDER SCREENING.—*

12 *Beginning January 1, 2027, as part of the en-*
 13 *rollment (or reenrollment or revalidation of en-*

14 *rollment) of a provider or supplier under this*

15 *title, and not less frequently than monthly dur-*

16 *ing the period that such provider or supplier is*

17 *so enrolled, the State conducts a check of any*

18 *database or similar system developed pursuant*

19 *to section 6401(b)(2) of the Patient Protection*

20 *and Affordable Care Act to determine whether*

21 *the Secretary has terminated the participation of*

22 *such provider or supplier under title XVIII, or*

23 *whether any other State has terminated the par-*

24 *ticipation of such provider or supplier under*

25 *such other State’s State plan under this title (or*

1 *waiver of the plan), or such other State's State*
2 *child health plan under title XXI (or waiver of*
3 *the plan).".*
