A BILL

To ensure that parents are aware of foreign influence in
their child's public school, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Transparency in Re-*
 5 *porting of Adversarial Contributions to Education Act”.*

6 **SEC. 2. PARENTS’ RIGHT TO KNOW ABOUT FOREIGN INFLU-**
 7 **ENCE.**

8 *(a) IN GENERAL.—Subpart 2 of part F of title VIII*
 9 *of the Elementary and Secondary Education Act of 1965*
 10 *(20 U.S.C. 7901 et seq.) is amended by adding at the end*
 11 *the following:*

12 **“SEC. 8549D. PARENTS’ RIGHT TO KNOW ABOUT FOREIGN**
 13 **INFLUENCE.**

14 *“(a) IN GENERAL.—As a condition of receiving funds*
 15 *under this Act, a local educational agency shall ensure that*
 16 *each elementary school and each secondary school served by*
 17 *such agency provides to each parent of a child attending*
 18 *the school, at a minimum—*

19 *“(1) the right (in a manner consistent with*
 20 *copyright law) to review, and make copies of free of*
 21 *cost, at least every four weeks and not later than 30*
 22 *days after submission of a written request by the par-*
 23 *ent, any curricular material or professional develop-*
 24 *ment material used at the school that was purchased,*
 25 *or otherwise obtained, using funds received from the*

1 *government of a foreign country or a foreign entity*
 2 *of concern;*

3 “(2) *the right to know, by written response pro-*
 4 *vided not later than 30 days after submission of a*
 5 *written request by the parent, how many personnel of*
 6 *the school are compensated, in whole or in part, using*
 7 *funds received from the government of a foreign coun-*
 8 *try or a foreign entity of concern; and*

9 “(3) *the right to know, by written response pro-*
 10 *vided not later than 30 days after submission of a*
 11 *written request by the parent, of—*

12 “(A) *any donation received by the school or*
 13 *local educational agency from a foreign country*
 14 *or a foreign entity of concern;*

15 “(B) *any agreement in writing (such as a*
 16 *contract or memorandum of understanding) be-*
 17 *tween the school or local educational agency and*
 18 *a foreign country or a foreign entity of concern;*
 19 *and*

20 “(C) *any financial transaction between the*
 21 *school or local educational agency and a foreign*
 22 *country or a foreign entity of concern.*

23 “(b) *DONATIONS, AGREEMENTS, AND FINANCIAL*
 24 *TRANSACTIONS.—The information described in subsection*
 25 *(a)(3) shall include, at minimum, the following:*

1 “(1) *The name of the foreign country or foreign*
2 *entity of concern.*

3 “(2) *In any case in which funds were received by*
4 *the school or local educational agency from a foreign*
5 *country or a foreign entity of concern—*

6 “(A) *the amount of such funds; and*

7 “(B) *any terms or conditions applicable to*
8 *the receipt of such funds.*

9 “(c) *NOTICE OF RIGHTS.—At the beginning of each*
10 *school year, a local educational agency receiving funds*
11 *under this Act shall ensure that each elementary school and*
12 *each secondary school served by such agency posts on a pub-*
13 *licly accessible website of the school or, if the school does*
14 *not operate a website, widely disseminates to the public, a*
15 *summary notice of the rights of parents described in sub-*
16 *sections (a) and (b).*

17 “(d) *NOTIFICATION OF REQUIREMENTS.—At the begin-*
18 *ning of each school year, the Secretary shall notify State*
19 *educational agencies about the requirements of this section.*
20 *As a condition of receiving funds under this Act, State edu-*
21 *cational agencies shall, at the beginning of each school year,*
22 *notify local educational agencies of the requirements of this*
23 *section.*

24 “(e) *DEFINITIONS.—In this section:*

1 “(1) *The term ‘foreign country’ means a foreign*
2 *country or a dependent territory or possession of a*
3 *foreign country. Such term does not include any of*
4 *the outlying areas.*

5 “(2) *The term ‘foreign entity of concern’ has the*
6 *meaning given such term in section 10612(a) of the*
7 *Research and Development, Competition, and Innova-*
8 *tion Act (42 U.S.C. 19221(a)).”.*

9 **(b) TABLE OF CONTENTS.**—*The table of contents in*
10 *section 2 of the Elementary and Secondary Education Act*
11 *of 1965 is amended by inserting after the item relating to*
12 *section 8549C the following:*

“Sec. 8549D. Parents’ right to know about foreign influence.”.
