Mr. GALLEGUO introduced the following bill; which was referred to the Committee on Education and the Workforce

# A BILL

To establish a competitive grant program for reducing the student absence rate of certain local educational agencies, and for other purposes.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,*

### 3 SECTION 1. SHORT TITLE.

4        This Act may be cited as the “Keeping our Students  
5        in School Act”.

## **6 SEC. 2. GRANT PROGRAM TO REDUCE CHRONIC STUDENT 7 ABSENCE.**

8       (a) IN GENERAL.—Not later than October 1 of the  
9 first fiscal year after the date of enactment of this Act,  
10 the Secretary of Education shall establish a program to

1 award grants, on a competitive basis, to eligible local edu-  
2 cational agencies for reducing the chronic absence rate of  
3 such eligible local educational agencies by carrying out any  
4 of the activities described in subsection (d).

5 (b) APPLICATIONS.—

6 (1) IN GENERAL.—To be eligible for a grant  
7 under this section, an eligible local educational agen-  
8 cy shall submit to the Secretary an application in  
9 such form, at such time, and containing such infor-  
10 mation as the Secretary determines appropriate, in-  
11 cluding the contents described in paragraph (2).

12 (2) CONTENTS.—An application for a grant  
13 under this section shall contain the following:

14 (A) The chronic absence rate of the eligible  
15 local educational agency.

16 (B) A description of any programs and re-  
17 sources to reduce the chronic absence rate of  
18 the eligible local educational agency that are in  
19 place at the time such application is submitted.

20 (C) A plan for how grant funds awarded  
21 under this section to the eligible local edu-  
22 cational agency would be used to reduce the  
23 chronic absence rate of the eligible local edu-  
24 cational agency.

(D) The estimated cost of implementing the plan described in subparagraph (C).

14       (c) DURATION; RENEWAL.—A grant awarded under  
15 this section shall be for a period of 1 year. The Secretary  
16 may renew a grant awarded under this section to an eligi-  
17 ble local educational agency for 1 or more additional 1-  
18 year grant periods.

19       (d) USE OF GRANT FUNDS.—An eligible local edu-  
20 cational agency that receives a grant under this section  
21 shall use the grant funds for 1 or more of the following  
22 activities:

23                   (1) Providing transportation services for stu-  
24                 dents traveling to and from schools served by the eli-  
25                 gible local educational agency.

- 1                         (2) Performing visits at places of residence of  
2                         a student who was absent for at least 10 percent of  
3                         the school days in the most recent school year for  
4                         the purpose of evaluating—  
5                                 (A) the well-being of the student; and  
6                                 (B) whether the number of school days  
7                         missed by the student has resulted in any learn-  
8                         ing loss by the student, including identifying  
9                         any risk factors present in the lifestyle of the  
10                         student that may contribute to learning loss.  
11                         (3) Establishing student mentorship programs.  
12                         (4) Establishing partnerships with State agen-  
13                         cies to reduce the chronic absence rate of the eligible  
14                         local educational agency that received the grant.  
15                         (5) Acquiring software or other data tools de-  
16                         signed to monitor student absence.  
17                         (6) Recruiting and retaining specialized instruc-  
18                         tional support personnel.  
19                         (7) Any other activities related to student ab-  
20                         sence that the Secretary determines appropriate.  
21                         (e) REPORTING.—Not later than 1 year after the  
22                         date that an eligible local educational agency receives a  
23                         grant under this section, the eligible local educational  
24                         agency shall provide a report to the Secretary that con-  
25                         tains any information reasonably required by the Sec-

1     retary, which includes a description of how grant funds  
2     awarded under this section to the eligible local educational  
3     agency were used to reduce the chronic absence rate of  
4     the eligible local educational agency.

5                 (f) DEFINITIONS.—In this section—

6                     (1) CHRONIC ABSENCE RATE.—The term  
7     “chronic absence rate”, used with respect to a local  
8     educational agency, means the quotient resulting  
9     from dividing—

10                         (A) the total number of students served by  
11     such local educational agency who were absent  
12     for at least 10 percent of the school days in the  
13     school year for which the most recent data is  
14     available from the Consolidated State Perform-  
15     ance Report administered by the Office of Ele-  
16     mentary and Secondary Education of the De-  
17     partment of Education, by

18                         (B) the total number of students served by  
19     such local educational agency in such school  
20     year.

21                     (2) ELIGIBLE LOCAL EDUCATIONAL AGENCY.—  
22     The term “eligible local educational agency” means  
23     a local educational agency that has a chronic ab-  
24     sence rate of 0.2 or more.

1                             (3) LOCAL EDUCATIONAL AGENCY; SPECIAL-  
2         IZED INSTRUCTIONAL SUPPORT PERSONNEL.—The  
3         terms “local educational agency” and “specialized  
4         instructional support personnel” have the meanings  
5         given the terms in section 8101 of the Elementary  
6         and Secondary Education Act of 1965 (20 U.S.C.  
7         7801).
