# RESOLUTION

set forth by the International Holocaust Remembrance Alliance for the enforcement of Federal antidiscrimination laws concerning education programs or activities, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House any bill specified  
3 in section 2 of this resolution. All points of order against  
4 consideration of each such bill are waived. The respective  
5 amendments in the nature of a substitute recommended  
6 by the Committee on Natural Resources now printed in  
7 each such bill shall be considered as adopted. Each such  
8 bill, as amended, shall be considered as read. All points  
9 of order against provisions in each such bill, as amended,  
10 are waived. The previous question shall be considered as  
11 ordered on each such bill, as amended, and on any further  
12 amendment thereto, to final passage without intervening  
13 motion except: (1) one hour of debate equally divided and  
14 controlled by the chair and ranking minority member of  
15 the Committee on Natural Resources or their respective  
16 designees; and (2) one motion to recommit.

17       SEC. 2. The bills referred to in the first section of  
18 this resolution are as follows:

19           (a) The bill (H.R. 615) to prohibit the Secretary of  
20 the Interior and the Secretary of Agriculture from prohib-  
21 iting the use of lead ammunition or tackle on certain Fed-  
22 eral land or water under the jurisdiction of the Secretary

1 of the Interior and the Secretary of Agriculture, and for  
2 other purposes.

3 (b) The bill (H.R. 2925) to amend the Omnibus  
4 Budget Reconciliation Act of 1993 to provide for security  
5 of tenure for use of mining claims for ancillary activities,  
6 and for other purposes.

7 (c) The bill (H.R. 3195) to rescind Public Land  
8 Order 7917, to reinstate mineral leases and permits in the  
9 Superior National Forest, to ensure timely review of Mine  
10 Plans of Operations, and for other purposes.

11 SEC. 3. Upon adoption of this resolution it shall be  
12 in order to consider in the House the bill (H.R. 764) to  
13 require the Secretary of the Interior to reissue regulations  
14 removing the gray wolf from the list of endangered and  
15 threatened wildlife under the Endangered Species Act of  
16 1973. All points of order against consideration of the bill  
17 are waived. The bill shall be considered as read. All points  
18 of order against provisions in the bill are waived. The pre-  
19 vious question shall be considered as ordered on the bill  
20 and on any amendment thereto to final passage without  
21 intervening motion except: (1) one hour of debate equally  
22 divided and controlled by the chair and ranking minority  
23 member of the Committee on Natural Resources or their  
24 respective designees; and (2) one motion to recommit.

1        SEC. 4. Upon adoption of this resolution it shall be  
2 in order to consider in the House the bill (H.R. 3397)  
3 to require the Director of the Bureau of Land Manage-  
4 ment to withdraw a rule of the Bureau of Land Manage-  
5 ment relating to conservation and landscape health. All  
6 points of order against consideration of the bill are waived.  
7 In lieu of the amendment in the nature of a substitute  
8 recommended by the Committee on Natural Resources  
9 now printed in the bill, an amendment in the nature of  
10 a substitute consisting of the text of Rules Committee  
11 Print 118-32 shall be considered as adopted. The bill, as  
12 amended, shall be considered as read. All points of order  
13 against provisions in the bill, as amended, are waived. The  
14 previous question shall be considered as ordered on the  
15 bill, as amended, and on any further amendment thereto,  
16 to final passage without intervening motion except: (1) one  
17 hour of debate equally divided and controlled by the chair  
18 and ranking minority member of the Committee on Nat-  
19 ural Resources or their respective designees; and (2) one  
20 motion to recommit.

21       SEC. 5. Upon adoption of this resolution it shall be  
22 in order to consider in the House the bill (H.R. 6285)  
23 to ratify and approve all authorizations, permits,  
24 verifications, extensions, biological opinions, incidental  
25 take statements, and any other approvals or orders issued

1 pursuant to Federal law necessary for the establishment  
2 and administration of the Coastal Plain oil and gas leasing  
3 program, and for other purposes. All points of order  
4 against consideration of the bill are waived. The amend-  
5 ment in the nature of a substitute recommended by the  
6 Committee on Natural Resources now printed in the bill,  
7 modified by the amendment printed in part A of the report  
8 of the Committee on Rules accompanying this resolution,  
9 shall be considered as adopted. The bill, as amended, shall  
10 be considered as read. All points of order against provi-  
11 sions in the bill, as amended, are waived. The previous  
12 question shall be considered as ordered on the bill, as  
13 amended, and on any further amendment thereto, to final  
14 passage without intervening motion except: (1) one hour  
15 of debate equally divided and controlled by the chair and  
16 ranking minority member of the Committee on Natural  
17 Resources or their respective designees; (2) the further  
18 amendment printed in part B of the report of the Com-  
19 mittee on Rules, if offered by the Member designated in  
20 the report, which shall be in order without intervention  
21 of any point of order, shall be considered as read, shall  
22 be separately debatable for the time specified in the report  
23 equally divided and controlled by the proponent and an  
24 opponent, and shall not be subject to a demand for a divi-  
25 sion of the question; and (3) one motion to recommit.

1        SEC. 6. Upon adoption of this resolution it shall be  
2 in order to consider in the House the bill (H.R. 6090)  
3 to provide for the consideration of a definition of anti-  
4 semitism set forth by the International Holocaust Remem-  
5 brance Alliance for the enforcement of Federal anti-  
6 discrimination laws concerning education programs or ac-  
7 tivities, and for other purposes. All points of order against  
8 consideration of the bill are waived. The bill shall be con-  
9 sidered as read. All points of order against provisions in  
10 the bill are waived. The previous question shall be consid-  
11 ered as ordered on the bill and on any amendment thereto  
12 to final passage without intervening motion except: (1) one  
13 hour of debate equally divided and controlled by the chair  
14 and ranking minority member of the Committee on the  
15 Judiciary or their respective designees; and (2) one motion  
16 to recommit.
