# **RESOLUTION**

Providing for consideration of the bill (H.R. 8369) to provide for the expeditious delivery of defense articles and defense services for Israel and other matters; providing for consideration of the bill (H.R. 7530) to limit youth offender status in the District of Columbia to individuals 18 years of age or younger, to direct the Attorney General of the District of Columbia to establish and operate a publicly accessible website containing updated statistics on juvenile crime in the District of Columbia, to amend the District of Columbia Home Rule Act to prohibit the Council of the District of Columbia from enacting changes to existing criminal liability sentences, and for other purposes; providing for consideration of the bill (H.R. 7343) to amend the Immigration and Nationality Act to provide for the detention of certain aliens who commit assault against law enforcement officers; providing for consideration of the bill (H.R. 8146) to require a report by the Attorney General on the impact the border crisis is having on law enforcement at the Federal, State, local, and Tribal level; providing for consideration of the bill (H.R. 7581) to require the Attorney General to develop reports relating to violent attacks against law enforcement officers, and for other purposes; providing for consideration of the bill (H.R. 354) to amend title 18, United States Code, to improve the Law Enforcement Officer Safety Act and provisions relating to the carrying of concealed weapons by law enforcement officers, and for other purposes; providing for consideration of the resolution (H. 1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 8369) to provide for the expeditious delivery of defense  
4 articles and defense services for Israel and other matters.  
5 All points of order against consideration of the bill are  
6 waived. The bill shall be considered as read. All points of  
7 order against provisions in the bill are waived. The pre-  
8 vious question shall be considered as ordered on the bill  
9 and on any amendment thereto to final passage without  
10 intervening motion except: (1) one hour of debate equally  
11 divided and controlled by the chair and ranking minority  
12 member of the Committee on Foreign Affairs or their re-  
13 spective designees; and (2) one motion to recommit.

14       SEC. 2. Upon adoption of this resolution it shall be  
15 in order to consider in the House the bill (H.R. 7530)  
16 to limit youth offender status in the District of Columbia  
17 to individuals 18 years of age or younger, to direct the  
18 Attorney General of the District of Columbia to establish  
19 and operate a publicly accessible website containing up-  
20 dated statistics on juvenile crime in the District of Colum-  
21 bia, to amend the District of Columbia Home Rule Act  
22 to prohibit the Council of the District of Columbia from  
23 enacting changes to existing criminal liability sentences,

1 and for other purposes. All points of order against consid-  
2 eration of the bill are waived. The amendment in the na-  
3 ture of a substitute recommended by the Committee on  
4 Oversight and Accountability now printed in the bill shall  
5 be considered as adopted. The bill, as amended, shall be  
6 considered as read. All points of order against provisions  
7 in the bill, as amended, are waived. The previous question  
8 shall be considered as ordered on the bill, as amended,  
9 and on any further amendment thereto, to final passage  
10 without intervening motion except: (1) one hour of debate  
11 equally divided and controlled by the chair and ranking  
12 minority member of the Committee on Oversight and Ac-  
13 countability or their respective designees; and (2) one mo-  
14 tion to recommit.

15 SEC. 3. At any time after adoption of this resolution  
16 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
17 declare the House resolved into the Committee of the  
18 Whole House on the state of the Union for consideration  
19 of the bill (H.R. 7343) to amend the Immigration and Na-  
20 tionality Act to provide for the detention of certain aliens  
21 who commit assault against law enforcement officers. The  
22 first reading of the bill shall be dispensed with. All points  
23 of order against consideration of the bill are waived. Gen-  
24 eral debate shall be confined to the bill and shall not ex-  
25 ceed one hour equally divided and controlled by the chair

1 and ranking minority member of the Committee on the  
2 Judiciary or their respective designees. After general de-  
3 bate the bill shall be considered for amendment under the  
4 five-minute rule. The amendment in the nature of a sub-  
5 stitute recommended by the Committee on the Judiciary  
6 now printed in the bill shall be considered as adopted in  
7 the House and in the Committee of the Whole. The bill,  
8 as amended, shall be considered as the original bill for  
9 the purpose of further amendment under the five-minute  
10 rule and shall be considered as read. All points of order  
11 against provisions in the bill, as amended, are waived. No  
12 further amendment to the bill, as amended, shall be in  
13 order except those printed in part A of the report of the  
14 Committee on Rules accompanying this resolution. Each  
15 such further amendment may be offered only in the order  
16 printed in the report, may be offered only by a Member  
17 designated in the report, shall be considered as read, shall  
18 be debatable for the time specified in the report equally  
19 divided and controlled by the proponent and an opponent,  
20 shall not be subject to amendment, and shall not be sub-  
21 ject to a demand for division of the question in the House  
22 or in the Committee of the Whole. All points of order  
23 against such further amendments are waived. At the con-  
24 clusion of consideration of the bill for amendment the  
25 Committee shall rise and report the bill, as amended, to

1 the House with such further amendments as may have  
2 been adopted. The previous question shall be considered  
3 as ordered on the bill, as amended, and on any further  
4 amendment thereto to final passage without intervening  
5 motion except one motion to recommit.

6 SEC. 4. At any time after adoption of this resolution  
7 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
8 declare the House resolved into the Committee of the  
9 Whole House on the state of the Union for consideration  
10 of the bill (H.R. 8146) to require a report by the Attorney  
11 General on the impact the border crisis is having on law  
12 enforcement at the Federal, State, local, and Tribal level.  
13 The first reading of the bill shall be dispensed with. All  
14 points of order against consideration of the bill are waived.  
15 General debate shall be confined to the bill and shall not  
16 exceed one hour equally divided and controlled by the chair  
17 and ranking minority member of the Committee on the  
18 Judiciary or their respective designees. After general de-  
19 bate the bill shall be considered for amendment under the  
20 five-minute rule. The amendment in the nature of a sub-  
21 stitute recommended by the Committee on the Judiciary  
22 now printed in the bill shall be considered as adopted in  
23 the House and in the Committee of the Whole. The bill,  
24 as amended, shall be considered as the original bill for  
25 the purpose of further amendment under the five-minute

1 rule and shall be considered as read. All points of order  
2 against provisions in the bill, as amended, are waived. No  
3 further amendment to the bill, as amended, shall be in  
4 order except those printed in part B of the report of the  
5 Committee on Rules accompanying this resolution. Each  
6 such further amendment may be offered only in the order  
7 printed in the report, may be offered only by a Member  
8 designated in the report, shall be considered as read, shall  
9 be debatable for the time specified in the report equally  
10 divided and controlled by the proponent and an opponent,  
11 shall not be subject to amendment, and shall not be sub-  
12 ject to a demand for division of the question in the House  
13 or in the Committee of the Whole. All points of order  
14 against such further amendments are waived. At the con-  
15 clusion of consideration of the bill for amendment the  
16 Committee shall rise and report the bill, as amended, to  
17 the House with such further amendments as may have  
18 been adopted. The previous question shall be considered  
19 as ordered on the bill, as amended, and on any further  
20 amendment thereto to final passage without intervening  
21 motion except one motion to recommit.

22 SEC. 5. Upon adoption of this resolution it shall be  
23 in order to consider in the House the bill (H.R. 7581)  
24 to require the Attorney General to develop reports relating  
25 to violent attacks against law enforcement officers, and

1 for other purposes. All points of order against consider-  
2 ation of the bill are waived. The amendment in the nature  
3 of a substitute recommended by the Committee on the Ju-  
4 diciary now printed in the bill shall be considered as adopt-  
5 ed. The bill, as amended, shall be considered as read. All  
6 points of order against provisions in the bill, as amended,  
7 are waived. The previous question shall be considered as  
8 ordered on the bill, as amended, and on any further  
9 amendment thereto, to final passage without intervening  
10 motion except: (1) one hour of debate equally divided and  
11 controlled by the chair and ranking minority member of  
12 the Committee on the Judiciary or their respective des-  
13 ignees; and (2) one motion to recommit.

14 SEC. 6. Upon adoption of this resolution it shall be  
15 in order to consider in the House the bill (H.R. 354) to  
16 amend title 18, United States Code, to improve the Law  
17 Enforcement Officer Safety Act and provisions relating to  
18 the carrying of concealed weapons by law enforcement offi-  
19 cers, and for other purposes. All points of order against  
20 consideration of the bill are waived. In lieu of the amend-  
21 ment in the nature of a substitute recommended by the  
22 Committee on the Judiciary now printed in the bill, an  
23 amendment in the nature of a substitute consisting of the  
24 text of Rules Committee Print 118–34 shall be considered  
25 as adopted. The bill, as amended, shall be considered as

1 read. All points of order against provisions in the bill, as  
2 amended, are waived. The previous question shall be con-  
3 sidered as ordered on the bill, as amended, and on any  
4 further amendment thereto, to final passage without inter-  
5 vening motion except: (1) one hour of debate equally di-  
6 vided and controlled by the chair and ranking minority  
7 member of the Committee on the Judiciary or their respec-  
8 tive designees; and (2) one motion to recommit.

9       SEC. 7. Upon adoption of this resolution it shall be  
10 in order without intervention of any point of order to con-  
11 sider in the House the resolution (H. Res. 1213) a resolu-  
12 tion regarding violence against law enforcement officers.  
13 The resolution shall be considered as read. The previous  
14 question shall be considered as ordered on the resolution  
15 and preamble to adoption without intervening motion or  
16 demand for division of the question except one hour of  
17 debate equally divided and controlled by the chair and  
18 ranking minority member of the Committee on the Judici-  
19 ary or their respective designees.

20       SEC. 8. Upon adoption of this resolution it shall be  
21 in order without intervention of any point of order to con-  
22 sider in the House the resolution (H. Res. 1210) con-  
23 demning the Biden border crisis and the tremendous bur-  
24 dens law enforcement officers face as a result. The resolu-  
25 tion shall be considered as read. The previous question

- 1 shall be considered as ordered on the resolution and pre-
- 2 amble to adoption without intervening motion or demand
- 3 for division of the question except one hour of debate
- 4 equally divided and controlled by the chair and ranking
- 5 minority member of the Committee on the Judiciary or
- 6 their respective designees.
