Mr. BURGESS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3564) to cancel recent changes made by the Federal Housing Finance Agency to the up-front loan level pricing adjustments charged by Fannie Mae and Freddie Mac for guarantee of single-family mortgages, and for other purposes; providing for consideration of the bill (H.R. 3799) to amend the Internal Revenue Code of 1986 to provide for health

reimbursement arrangements integrated with individual health insurance coverage; and providing for consideration of the resolution (H. Res. 461) condemning the use of elementary and secondary school facilities to provide shelter for aliens who are not admitted to the United States.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3564) to cancel recent changes
6 made by the Federal Housing Finance Agency to the up-
7 front loan level pricing adjustments charged by Fannie
8 Mae and Freddie Mac for guarantee of single-family mort-
9 gages, and for other purposes. The first reading of the
10 bill shall be dispensed with. All points of order against
11 consideration of the bill are waived. General debate shall
12 be confined to the bill and amendments specified in this
13 section and shall not exceed one hour equally divided and
14 controlled by the chair and ranking minority member of
15 the Committee on Financial Services or their respective
16 designees. After general debate the bill shall be considered
17 for amendment under the five-minute rule. In lieu of the
18 amendment in the nature of a substitute recommended by
19 the Committee on Financial Services now printed in the
20 bill, an amendment in the nature of a substitute consisting

1 of the text of Rules Committee Print 118-8, modified by
2 the amendment printed in part A of the report of the Com-
3 mittee on Rules accompanying this resolution, shall be
4 considered as adopted in the House and in the Committee
5 of the Whole. The bill, as amended, shall be considered
6 as the original bill for the purpose of further amendment
7 under the five-minute rule and shall be considered as read.
8 All points of order against provisions in the bill, as amend-
9 ed, are waived. No further amendment to the bill, as
10 amended, shall be in order except those printed in part
11 B of the report of the Committee on Rules. Each such
12 further amendment may be offered only in the order print-
13 ed in the report, may be offered only by a Member des-
14 ignated in the report, shall be considered as read, shall
15 be debatable for the time specified in the report equally
16 divided and controlled by the proponent and an opponent,
17 shall not be subject to amendment, and shall not be sub-
18 ject to a demand for division of the question in the House
19 or in the Committee of the Whole. All points of order
20 against such further amendments are waived. At the con-
21 clusion of consideration of the bill for amendment the
22 Committee shall rise and report the bill, as amended, to
23 the House with such further amendments as may have
24 been adopted. The previous question shall be considered
25 as ordered on the bill, as amended, and on any further

1 amendment thereto to final passage without intervening
2 motion except one motion to recommit.

3 SEC. 2. At any time after adoption of this resolution
4 the Speaker may, pursuant to clause 2(b) of rule XVIII,
5 declare the House resolved into the Committee of the
6 Whole House on the state of the Union for consideration
7 of the bill (H.R. 3799) to amend the Internal Revenue
8 Code of 1986 to provide for health reimbursement ar-
9 rangements integrated with individual health insurance
10 coverage. The first reading of the bill shall be dispensed
11 with. All points of order against consideration of the bill
12 are waived. General debate shall be confined to the bill
13 and amendments specified in this section and shall not ex-
14 ceed 80 minutes equally divided among and controlled by
15 the chair and ranking minority member of the Committee
16 on Education and the Workforce or their respective des-
17 ignees and the chair and ranking minority member of the
18 Committee on Ways and Means or their respective des-
19 ignees. After general debate the bill shall be considered
20 for amendment under the five-minute rule. In lieu of the
21 amendment in the nature of a substitute recommended by
22 the Committee on Ways and Means now printed in the
23 bill, an amendment in the nature of a substitute consisting
24 of the text of Rules Committee Print 118-9, modified by
25 the amendment printed in part C of the report of the Com-

1 mittee on Rules accompanying this resolution, shall be
2 considered as adopted in the House and in the Committee
3 of the Whole. The bill, as amended, shall be considered
4 as the original bill for the purpose of further amendment
5 under the five-minute rule and shall be considered as read.
6 All points of order against provisions in the bill, as amend-
7 ed, are waived. No further amendment to the bill, as
8 amended, shall be in order except those printed in part
9 D of the report of the Committee on Rules. Each such
10 further amendment may be offered only in the order print-
11 ed in the report, may be offered only by a Member des-
12 ignated in the report, shall be considered as read, shall
13 be debatable for the time specified in the report equally
14 divided and controlled by the proponent and an opponent,
15 shall not be subject to amendment, and shall not be sub-
16 ject to a demand for division of the question in the House
17 or in the Committee of the Whole. All points of order
18 against such further amendments are waived. At the con-
19 clusion of consideration of the bill for amendment the
20 Committee shall rise and report the bill, as amended, to
21 the House with such further amendments as may have
22 been adopted. The previous question shall be considered
23 as ordered on the bill, as amended, and on any further
24 amendment thereto to final passage without intervening
25 motion except one motion to recommit.

1 SEC. 3. Upon adoption of this resolution it shall be
2 in order without intervention of any point of order to con-
3 sider in the House the resolution (H. Res. 461) con-
4 demning the use of elementary and secondary school facili-
5 ties to provide shelter for aliens who are not admitted to
6 the United States. The amendments to the resolution and
7 the preamble recommended by the Committee on Edu-
8 cation and the Workforce now printed in the resolution
9 shall be considered as adopted. The resolution, as amend-
10 ed, shall be considered as read. The previous question shall
11 be considered as ordered on the resolution and preamble,
12 as amended, to adoption without intervening motion ex-
13 cept one hour of debate equally divided and controlled by
14 the chair and ranking minority member of the Committee
15 on Education and the Workforce or their respective des-
16 ignees.
