## A BILL

To amend the Federal Crop Insurance Act to require research and development regarding a policy to insure wine grapes against losses due to smoke exposure, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Smoke Exposure Crop  
5       Insurance Act of 2023”.

1   **SEC. 2. POLICY TO INSURE WINE GRAPES AGAINST LOSSES**

2                   **DUE TO SMOKE EXPOSURE.**

3       Section 522(c) of the Federal Crop Insurance Act (7  
4   U.S.C. 1522(c)) is amended by adding at the end the fol-  
5 lowing:

6                   **“(20) WINE GRAPES.—**

7                   **“(A) IN GENERAL.**—Not later than 1 year  
8       after the date of enactment of this paragraph,  
9       the Corporation shall carry out research and  
10      development, or offer to enter into 1 or more  
11      contracts with 1 or more qualified persons to  
12      carry out research and development, regarding  
13      a policy to insure wine grapes (including wine  
14      grapes produced in the States of California, Or-  
15      egon, and Washington) against losses due to  
16      wildfire smoke exposure.

17                   **“(B) AVAILABILITY OF POLICY.**—Notwith-  
18      standing the second sentence of section  
19      508(a)(1), and section 508(a)(2), not later than  
20      18 months after the date of enactment of this  
21      paragraph, the Corporation shall make available  
22      a policy described in subparagraph (A) if the  
23      requirements of section 508(h) are met with re-  
24      spect to that policy.

25                   **“(C) REPORT.**—Not later than 2 years  
26      after the date of enactment of this paragraph,

1           the Corporation shall submit to the Committees  
2           on Appropriations and Agriculture of the House  
3           of Representatives and the Committees on Ap-  
4           propriations and Agriculture, Nutrition, and  
5           Forestry of the Senate a report that includes—  
6                 “(i) the results of the research carried  
7                 out under subparagraph (A);  
8                 “(ii) a description of the policy made  
9                 available under subparagraph (B); and  
10                “(iii) an evaluation of the feasibility of  
11                a policy that allows producers to claim an  
12                indemnity through post-harvest, post-  
13                vinification testing, if such testing dem-  
14                onstrates smoke damage that was not de-  
15                tectable prior to harvest.”.
