## A BILL

To amend the Department of Agriculture Reorganization Act of 1994 to establish an Assistant Secretary of Agriculture for Tribal Relations, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Strengthening the Of-  
5 fice of Tribal Relations Act of 2023”.

1   **SEC. 2. ASSISTANT SECRETARY OF AGRICULTURE FOR**  
2           **TRIBAL RELATIONS.**

3       (a) IN GENERAL.—Section 218 of the Department of  
4   Agriculture Reorganization Act of 1994 (7 U.S.C. 6918)  
5   is amended—

6           (1) in subsection (a)—

7               (A) in paragraph (2), by striking “and” at  
8               the end;

9               (B) in paragraph (3), by striking the pe-  
10              riod at the end and inserting “; and”; and

11               (C) by adding at the end the following:

12              “(4) Assistant Secretary of Agriculture for  
13              Tribal Relations.”;

14              (2) in subsection (b), by striking “(1) or (3)”  
15              and inserting “(1), (3), or (4)”; and

16              (3) by adding at the end the following:

17              “(d) ASSISTANT SECRETARY OF AGRICULTURE FOR  
18              TRIBAL RELATIONS.—

19              “(1) APPOINTMENT.—In appointing an indi-  
20              vidual to the position of Assistant Secretary for  
21              Tribal Relations, the Secretary shall give priority to  
22              an individual who has a background in Tribal rela-  
23              tions or affairs.

24              “(2) DUTIES.—The Secretary may delegate to  
25              the Assistant Secretary for Tribal Relations respon-  
26              sibility for—

1                 “(A) overseeing the Office of Tribal Rela-  
2                 tions of the Department;

3                 “(B) planning, coordinating, and imple-  
4                 menting policies and programs of the Depart-  
5                 ment serving Indian Tribes and Tribal organi-  
6                 zations;

7                 “(C) coordinating Tribal programs and ac-  
8                 tivities in all offices and agencies of the Depart-  
9                 ment; and

10                 “(D) being a participant in any negotiated  
11                 rulemakings relating to, or having an impact  
12                 on, projects, programs, or funding associated  
13                 with the Tribal programs of the Department.”.

14                 (b) COMPENSATION.—Section 5315 of title 5, United  
15                 States Code, is amended by striking “Assistant Secre-  
16                 taries of Agriculture (3)” and inserting “Assistant Secre-  
17                 taries of Agriculture (4)”.

18                 (c) CONFORMING AMENDMENT.—Section 296(b) of  
19                 the Department of Agriculture Reorganization Act of  
20                 1994 (7 U.S.C. 7014(b)) is amended by adding at the end  
21                 the following:

22                 “(11) The authority of the Secretary to estab-  
23                 lish within the Department the position of Assistant  
24                 Secretary of Agriculture for Tribal Relations, and

1        delegate duties to the Assistant Secretary, under  
2        section 218.”.
