A BILL

To modernize unemployment compensation benefits.

12	graph, the term 'earned income' has the mean-
13	ing given that term in section $32(c)(2)$ of the

15	"(5) EARNINGS DISREGARD.—
16	"(A) IN GENERAL.—Subject to subpara-
17	graph (B), an individual may earn up to 100
18	percent of the amount of the individual's weekly
19	jobseeker allowance without losing eligibility for
20	the weekly jobseeker allowance.
21	"(B) REDUCTION.—In the case of an indi-
22	vidual who is not receiving regular compensa-
23	tion or extended compensation under any State
24	of Federal law with respect to a week, if the in-
25	dividual's earnings are greater than $\frac{1}{4}$ of the

1	amount of the individual's weekly jobseeker al-
2	lowance (determined after application of para-
3	graphs (2) , (3) , and (4)) for the week, the
4	amount of the individual's weekly jobseeker al-

15	amount of a jobseeker allowance payable to any indi-
16	vidual for whom a jobseeker allowance account is es-
17	tablished under paragraph (1) may not exceed the
18	amount established in such account for such indi-
19	vidual.
20	"(3) BASE-TIER JOBSEEKER ALLOWANCE.—The
21	amount established in an account under paragraph
22	(1) shall be equal to 26 times the amount of the
23	weekly jobseeker allowance (as determined under
24	subsection (b), taking into account the application of
25	paragraph (4) of such subsection but not taking into

- account the application of paragraphs (2), (3), and
 (5) of such subsection). Such amount shall be re ferred to in this section as the 'base-tier jobseeker
 allowance'.
 - "(4) FIRST-TIER JOBSEEKER ALLOWANCE.—

"(A) IN GENERAL.—If, at the time that 6 7 the amount added to an individual's account 8 under paragraph (3) is exhausted, or at any 9 time during the individual's benefit year, such 10 individual's State is in an extended benefit pe-11 riod under section 203(d) of the Federal-State 12 Extended Unemployment Compensation Act of 13 1970 (26 U.S.C. 3304 note), such account shall 14 be augmented by an amount (in this section re-15 ferred to as 'first-tier jobseeker allowance') 16 equal to 13 times the amount of the weekly job-17 seeker allowance (as determined under sub-18 section (b), taking into account the application 19 of paragraph (4) of such subsection but not 20 taking into account the application of para-21 graphs (2), (3), and (5) of such subsection).

22 "(B) LIMITATION.—The account of an in23 dividual may be augmented not more than once
24 under this paragraph.

1 "(5) SECOND-TIER ADDITIONAL JOBSEEKER 2 ALLOWANCE.—

"(A) IN GENERAL.—If, at the time that 3 the amount added to an individual's account 4 5 under paragraph (4) is exhausted, or at any 6 time during the individual's benefit year, such 7 individual's State is in a second-tier high unem-8 ployment period under section 202(b)(3)(B)(i)9 of the Federal-State Extended Unemployment 10 Compensation Act of 1970 (26 U.S.C. 3304 11 note), such account shall be augmented by an 12 amount (in this section referred to as 'second-13 tier jobseeker allowance') equal to 13 times the 14 amount of the weekly jobseeker allowance (as 15 determined under subsection (b) of this section, taking into account the application of para-16 17 graph (4) of such subsection but not taking into 18 account the application of paragraphs (2), (3), 19 and (5) of such subsection).

20 "(B) LIMITATION.—The account of an in21 dividual may be augmented not more than once
22 under this paragraph.

23 "(6) THIRD-TIER ADDITIONAL JOBSEEKER AL24 LOWANCE.—

1	"(A) IN GENERAL.—If, at the time that

10	amount (in this section referred to as 'third-tier
11	jobseeker allowance') equal to 13 times the
12	amount of the weekly jobseeker allowance (as
13	determined under subsection (b) of this section,
14	taking into account the application of para-
15	graph (4) of such subsection but not taking into
16	account the application of paragraphs (2) , (3) ,
17	and (5) of such subsection).
18	"(B) LIMITATION.—The account of an in-
19	dividual may be augmented not more than once
20	under this paragraph.
21	"(7) FOURTH-TIER ADDITIONAL JOBSEEKER
22	ALLOWANCE.—
23	"(A) IN GENERAL.—If, at the time that
24	the amount added to an individual's account
25	under paragraph (6) is exhausted, or at any

1 time during the individual's benefit year, such 2 individual's State is in a fourth-tier high unemployment period under section 202(b)(3)(B)(iii) 3 4 of the Federal-State Extended Unemployment 5 Compensation Act of 1970 (26 U.S.C. 3304 6 note), such account shall be augmented by an 7 amount (in this section referred to as 'fourth-8 tier jobseeker allowance') equal to 13 times the 9 amount of the weekly jobseeker allowance (as 10 determined under subsection (b) of this section, 11 taking into account the application of para-12 graph (4) of such subsection but not taking into 13 account the application of paragraphs (2), (3), 14 and (5) of such subsection). 15 "(B) LIMITATION.—The account of an in-16 dividual may be augmented not more than once 17 under this paragraph. 18 "(d) PAYMENTS TO STATES.— 19 "(1) IN GENERAL.— 20 "(A) FULL REIMBURSEMENT.—There shall 21 be paid to each State an amount equal to 100 22 percent of— "(i) the total amount of jobseeker al-23 24 lowances paid to individuals by the State 25 pursuant to this section; and

"(ii) any additional administrative ex penses incurred by the State by reason of
 making such payments (as determined by
 the Secretary of Labor).

"(B) TERMS OF PAYMENTS .- Sums pav-5 6 able to any State under this section shall be 7 payable, either in advance or by way of reim-8 bursement (as determined by the Secretary of 9 Labor), in such amounts as the Secretary of Labor estimates the State will be entitled to re-10 11 ceive under this section for each calendar 12 month, reduced or increased, as the case may 13 be, by any amount by which the Secretary of 14 Labor finds that the Secretary's estimates for 15 any prior calendar month were greater or less 16 than the amounts that should have been paid to 17 the State. Such estimates may be made on the 18 basis of such statistical, sampling, or other 19 method as may be agreed upon by the Secretary 20 of Labor and the State agency of the State in-21 volved.

"(2) CERTIFICATIONS.—The Secretary of
Labor shall from time to time certify to the Secretary of the Treasury for payment to each State the
sums payable to such State under this section.

1	"(3) DEPOSIT.—Sums payable to any State

4	Amounts deposited under preceding sentence may

11	"(e) Fraud and Overpayments.—
12	"(1) IN GENERAL.—If an individual knowingly
13	has made, or caused to be made by another, a false
14	statement or representation of a material fact, or
15	knowingly has failed, or caused another to fail, to
16	disclose a material fact, and as a result of such false
17	statement or representation or of such nondisclosure
18	such individual has received an amount of jobseeker
19	allowances to which such individual was not entitled,
20	such individual—
21	"(A) shall be ineligible for further job-
22	seeker allowances in accordance with the provi-
23	sions of the applicable State unemployment
24	compensation law relating to fraud in connec-

1	tion with a claim for unemployment compensa-
2	tion; and
3	"(B) shall be subject to prosecution under
4	section 1001 of title 18, United States Code.
5	"(2) Repayment.—In the case of individuals
6	who have received amounts of jobseeker allowances
7	to which they were not entitled, the State shall re-
8	quire such individuals to repay the amounts of such
9	jobseeker allowances to the State agency, except that
10	the State agency shall waive such repayment if it de-
11	termines that—
12	"(A) the payment of such jobseeker allow-
13	ance was not based on fraud on the part of any
14	such individual; and
15	"(B) such repayment would be contrary to
16	equity and good conscience.
17	"(3) Recovery by state agency.—
18	"(A) IN GENERAL.—The State agency may
19	recover the amount to be repaid, or any part
20	thereof, by deductions from any jobseeker al-
21	lowance payable to such individual or from any
22	unemployment compensation payable to such
23	individual under any State or Federal unem-
24	ployment compensation law administered by the
25	State agency or under any other State or Fed-

eral law administered by the State agency 1 2 which provides for the payment of any assistance or allowance with respect to any week of 3 4 unemployment, during the 3-year period after 5 the date such individual received the payment 6 of the jobseeker allowance to which they were 7 not entitled, in accordance with the same proce-8 dures as apply to the recovery of overpayments 9 of regular unemployment benefits paid by the 10 State.

"(B) OPPORTUNITY FOR HEARING.—No
repayment shall be required, and no deduction
shall be made, until a determination has been
made, notice thereof and an opportunity for a
fair hearing has been given to the individual,
and the determination has become final.

"(4) REVIEW.—Any determination by a State
agency under this section shall be subject to review
in the same manner and to the same extent as determinations under the State unemployment compensation law, and only in that manner and to that extent.

23 "(5) DEPOSIT IN STATE UNEMPLOYMENT
24 FUND.—Any amount recovered by a State agency
25 pursuant to this section shall be deposited in the ac-

count of such State in the Unemployment Trust
 Fund. Amounts deposited under preceding sentence
 may only be used by the State for the payment of
 jobseeker allowances under this section.

"(f) Payment To Be Disregarded for Purposes 5 6 OF ALL FEDERAL AND FEDERALLY ASSISTED PRO-7 GRAMS.—A jobseeker allowance payment shall not be re-8 garded as income and shall not be regarded as a resource 9 for the month of receipt and the following 12 months, for 10 purposes of determining the eligibility of the recipient (or the recipient's spouse or family) for benefits or assistance, 11 12 or the amount or extent of benefits or assistance, under 13 any Federal program or under any State or local program financed in whole or in part with Federal funds. 14

15 "(g) REGULATIONS.—Not later than 3 months after
16 the date of enactment of this section, the Secretary of
17 Labor shall issue regulations to carry out this section.".
