Mr. WHITEHOUSE (for himself and Mr. CASSIDY) introduced the following bill;
which was read twice and referred to the Committee on Finance

A BILL

To amend section 431 of the Tariff Act of 1930 to clarify the requirements relating to disclosure of vessel, aircraft, or vehicle manifest information.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Manifest Moderniza-
5 tion Act of 2023”.

6 **SEC. 2. DISCLOSURE OF VESSEL, AIRCRAFT, OR VEHICLE**
7 **MANIFEST INFORMATION.**

8 (a) EXPANSION AND CLARIFICATION OF DISCLOSURE
9 REQUIREMENT.—Section 431 of the Tariff Act of 1930
10 (19 U.S.C. 1431) is amended—

1 (1) in subsection (a), by striking “section 4197
2 of the Revised Statutes of the United States (46
3 U.S.C. App. 91)” and inserting “section 60105 of
4 title 46, United States Code, and every aircraft or
5 vehicle arriving in the United States as described in
6 section 433,”; and

7 (2) in subsection (c)(1)—

8 (A) in the matter preceding subparagraph
9 (A), by striking “subparagraph (2)” and all
10 that follows through “shall be available” and
11 inserting “paragraph (2), the following informa-
12 tion, when contained in a vessel, aircraft, or ve-
13 hicle manifest, shall be available”;

14 (B) in subparagraph (B), by inserting be-
15 fore the end period the following: “and the sub-
16 headings of the Harmonized Tariff Schedule of
17 the United States under which the cargo is
18 classifiable”; and

19 (C) by striking subparagraph (G) and in-
20 serting the following:

21 “(G) The country in which the cargo was pro-
22 duced and the last country through which the cargo
23 was transported.”.

1 (b) PROTECTION OF PERSONALLY IDENTIFIABLE IN-
2 FORMATION.—Section 431(c) of the Tariff Act of 1930
3 (19 U.S.C. 1431(c)) is amended—

4 (1) in paragraph (2)—

5 (A) by redesignating subparagraphs (A)
6 and (B) as clauses (i) and (ii), respectively;

7 (B) by inserting “(A)” after “(2)”; and

8 (C) by adding at the end the following:

9 “(B) The Secretary shall ensure that the fol-
10 lowing information is removed from any manifest
11 signed, produced, delivered, or electronically trans-
12 mitted under this section before access to the mani-
13 fest is provided to the public:

14 “(i) Social Security numbers.

15 “(ii) Passport numbers.

16 “(iii) Dates of birth.

17 “(iv) Personal phone numbers.

18 “(v) Personal email addresses.

19 “(vi) Driver’s license and State identifica-
20 tion numbers.

21 “(vii) Residential addresses that are not
22 the primary address of the trade or business
23 (excluding ZIP Codes).

24 “(viii) Names of individuals who are end-
25 consumers.

1 “(C) Nothing in this paragraph may be con-
2 strued to permit the removal from a manifest
3 signed, produced, delivered, or electronically trans-
4 mitted under this section of the name, address, or
5 identification number of a business.”; and

6 (2) by adding at the end the following:

7 “(4) Each manifest signed, produced, delivered, or
8 electronically transmitted under this section shall include
9 a checkbox to indicate whether the shipment is going to
10 a private individual or a company.”.

11 (c) EFFECTIVE DATE.—The amendments made by
12 this section shall take effect on the date that is 30 days
13 after the date of the enactment of this Act.
