AN ACT

To take certain land in the State of Washington into trust for the benefit of the Puyallup Tribe of the Puyallup Reservation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Puyallup Tribe of Indi-
- 3 ans Land Into Trust Confirmation Act of 2023".
- 4 SEC. 2. LAND TO BE TAKEN INTO TRUST FOR THE BENEFIT
- 5 OF THE PUYALLUP TRIBE OF THE PUYALLUP
- 6 RESERVATION.
- 7 (a) In General.—The approximately 17.264 acres
- 8 of land owned in fee by the Puyallup Tribe of the Puyallup
- 9 Reservation in Pierce County, Washington, and described
- 10 in subsection (b) is hereby taken into trust by the United
- 11 States for the benefit of the Puyallup Tribe of the Puy-
- 12 allup Reservation.
- 13 (b) LAND DESCRIPTIONS.—
- 14 (1) PARCEL 1.—Lots 1 to 4, inclusive, Block
- 15 85, Map of Tacoma Tidelands, as surveyed and plat-
- ted by the Board of Appraisers of Tide and Shore
- 17 Lands for Pierce County, according to Plat filed for
- 18 record on September 14, 1895, in the Office of the
- 19 County Auditor, in Tacoma, Pierce County, Wash-
- ington.
- 21 (2) PARCEL 2.—Lots 5 to 9, inclusive, Block

- 11 (c) ADMINISTRATION.—Land taken into trust under
- 12 subsection (a) shall be—
- 13 (1) part of the Reservation of the Puyallup
- 14 Tribe of the Puyallup Reservation; and
- 15 (2) administered in accordance with the laws
- and regulations generally applicable to property held
- in trust by the United States for the benefit of an
- 18 Indian Tribe.
- 19 (d) Environmental Liability.—Notwithstanding
- 20 any other provision of law, the United States shall not
- 21 be liable for any environmental contamination that oc-
- 22 curred on the land described in subsection (b) on or before
- 23 the date on which that land is taken into trust under sub-
- 24 section (a).

- 1 (e) Gaming Prohibited.—Land taken into trust
- 2 under subsection (a) shall not be used for any class II
- 3 gaming or class III gaming under the Indian Gaming Reg-
- 4 ulatory Act $(25~\mathrm{U.S.C.}~2701~\mathrm{et}~\mathrm{seq.})$ (as those terms are
- 5 defined in section 4 of that Act (25 U.S.C. 2703)).
