A BILL

To reauthorize the Northwest Straits Marine Conservation Initiative Act to promote the protection of the resources of the Northwest Straits, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Northwest Straits Ma-
5 rine Conservation Initiative Reauthorization Act of 2024”.

1 **SEC. 2. REAUTHORIZATION OF NORTHWEST STRAITS MA-**
 2 **RINE CONSERVATION INITIATIVE ACT.**

3 The Northwest Straits Marine Conservation Initiative
 4 Act (title IV of Public Law 105–384; 112 Stat. 3458) is
 5 amended—

6 (1) in section 402, by striking “Commission (in
 7 this title referred to as the ‘Commission’).” and in-
 8 serting “Commission.”; and

9 (2) by striking sections 403, 404, and 405 and
 10 inserting the following:

11 **~~“SEC. 403. FINDINGS.~~**

12 ~~“Congress makes the following findings:~~

13 ~~“(1) The marine waters and ecosystem of the~~
 14 ~~Northwest Straits in Puget Sound in the State of~~
 15 ~~Washington represent a unique resource of enor-~~
 16 ~~mous environmental and economic value to the peo-~~
 17 ~~ple of the United States.~~

18 ~~“(2) During the 20th century, the environ-~~
 19 ~~mental health of the Northwest Straits declined dra-~~
 20 ~~matically as indicated by impaired water quality, de-~~
 21 ~~clines in marine wildlife, collapse of harvestable ma-~~
 22 ~~rine species, loss of critical marine habitats, ocean~~
 23 ~~acidification, and sea level rise.~~

24 ~~“(3) Increasingly, the Northwest Straits have~~
 25 ~~been threatened by sea level rise, ocean acidification,~~
 26 ~~and other effects of climate change.~~

1 “(4) This title was enacted to tap the unprece-
2 dented level of citizen stewardship demonstrated in
3 the Northwest Straits and create a mechanism to
4 mobilize public support and raise capacity for local
5 efforts to protect and restore the ecosystem of the
6 Northwest Straits.

7 “(5) The Northwest Straits Marine Conserva-
8 tion Initiative helps the National Oceanic and At-
9 mospheric Administration and other Federal agen-
10 cies with their marine missions by fostering local in-
11 terest in marine issues and involving diverse commu-
12 nities.

13 “(6) The Northwest Straits Marine Conserva-
14 tion Initiative shares many of the same goals with
15 the National Oceanic and Atmospheric Administra-
16 tion, including fostering citizen stewardship of ma-
17 rine resources, general ecosystem management, and
18 protecting federally managed marine species.

19 “(7) Ocean literacy, kelp habitat conservation
20 and monitoring, Veterans Conservation Corps in-
21 ternships, and removal of marine debris projects are
22 examples of previous and ongoing partnerships be-
23 tween the Northwest Straits Marine Conservation
24 Initiative and the National Oceanic and Atmospheric

1 ~~Administration. Areas of partnership may evolve~~
 2 ~~with emerging opportunities.~~

3 **“SEC. 404403. DEFINITIONS.**

4 “In this title:

5 “(1) COMMISSION.—The term ‘Commission’
 6 means the Northwest Straits Advisory Commission
 7 established by section 402.

8 “(2) MARINE RESOURCES COMMITTEE.—The
 9 term ‘marine resources committee’ means a county
 10 government committee that assists in assessing ma-
 11 rine resource and conservation needs.

12 “(3) NORTHWEST STRAITS REGION.—The term
 13 ‘Northwest Straits region’ means the marine waters
 14 of the Strait of Juan de Fuca and of Puget Sound
 15 from the Canadian border to the south end of Sno-
 16 homish County.

17 “(4) TRIBAL GOVERNMENT.—The term ‘Tribal
 18 government’ means the recognized governing body of
 19 any Indian or Alaska Native tribe, band, nation,
 20 pueblo, village, community, component band, or com-
 21 ponent reservation individually identified (including
 22 parenthetically) in the list published most recently as
 23 of the date of enactment of the Northwest Straits
 24 Marine Conservation Initiative Reauthorization Act
 25 of 2024 pursuant to section 104 of the Federally

1 Recognized Indian Tribe List Act of 1994 (25
2 U.S.C. 5131).

3 “(5) UNDER SECRETARY.—The term ‘Under
4 Secretary’ means the Under Secretary of Commerce
5 for Oceans and Atmosphere.

6 **“SEC. 405404. MEMBERSHIP OF THE COMMISSION.**

7 “(a) COMPOSITION.—

8 “(1) IN GENERAL.—The Commission shall be
9 composed of 14 members, except as provided in
10 paragraph (2), who shall be appointed as follows:

11 “(A) One member appointed by a con-
12 sensus of the members of a marine resources
13 committee for San Juan County, Washington.

14 “(B) One member appointed by a con-
15 sensus of the members of a marine resources
16 committee for Island County, Washington.

17 “(C) One member appointed by a con-
18 sensus of the members of a marine resources
19 committee for Skagit County, Washington.

20 “(D) One member appointed by a con-
21 sensus of the members of a marine resources
22 committee for Whatcom County, Washington.

23 “(E) One member appointed by a con-
24 sensus of the members of a marine resources
25 committee for Snohomish County, Washington.

1 “(F) One member appointed by a con-
 2 sensus of the members of a marine resources
 3 committee for Clallam County, Washington.

4 “(G) One member appointed by a con-
 5 sensus of the members of a marine resources
 6 committee for Jefferson County, Washington.

7 “(H) Two members appointed by the Sec-
 8 retary of the Interior, in coordination with the
 9 Northwest Indian Fisheries Commission and in
 10 consultation with the Tribal governments af-
 11 fected by this title, to represent the interests of
 12 such Tribal governments.

13 “(I) One member appointed by the Gov-
 14 ernor of the State of Washington to represent
 15 the interests of the Puget Sound Partnership.

16 “(J) Four members appointed by the Gov-
 17 ernor of the State of Washington who—

18 “(i) are residents of the State of
 19 Washington; and

20 “(ii) are not employed by a Federal,
 21 State, or local government, excluding an
 22 institution of higher education.

23 “(2) ADDITIONAL MEMBERS.—The Commission
 24 may, as determined necessary to improve the ability
 25 of the Commission to perform the duties of the

1 Commission under section ~~406~~ 405(b), appoint mem-
 2 bers in addition to those appointed under paragraph
 3 (1). Any such additional member shall be appointed
 4 by a consensus of the members of a marine re-
 5 sources committee that is not described in such
 6 paragraph.

7 “(b) VACANCIES.—A vacancy in the Commission
 8 shall be filled in the manner in which the original appoint-
 9 ment was made.

10 “(c) CHAIRPERSON.—The Commission shall select a
 11 Chairperson from among its members.

12 “(d) MEETING.—The Commission shall meet at the
 13 call of the Chairperson, but not less frequently than quar-
 14 terly.

15 “(e) LIAISON.—

16 “(1) IN GENERAL.—The Under Secretary, in
 17 consultation with the Commission, shall appoint an
 18 employee of the National Oceanic and Atmospheric
 19 Administration—

20 “(A) to serve as a liaison between the
 21 Commission and the Department of Commerce;

22 “(B) to coordinate programs of the Na-
 23 tional Oceanic and Atmospheric Administration
 24 with activities related to the goal of the Com-
 25 mission described in section ~~406~~ 405(a); and

1 “(C) to perform additional liaison func-
 2 tions benefitting the Commission and the Na-
 3 tional Oceanic and Atmospheric Administration,
 4 which may include, as agreed to by the Com-
 5 mission and the National Oceanic and Atmos-
 6 pheric Administration, attending meetings and
 7 other events of the Commission as a nonvoting
 8 participant.

9 “(2) LIMITATION.—Service as a member of the
 10 Commission by the employee appointed under para-
 11 graph (1)—

12 “(A) is limited to the employee’s service as
 13 a liaison; and

14 “(B) does not obligate the employee to per-
 15 form any duty of the Commission under section
 16 ~~406~~ 405(b).

17 “(f) ADMINISTRATION.—The Commission may enter
 18 into cooperative agreements with the State of Washington
 19 for staffing and administrative services for the purposes
 20 of supporting the duties of the Commission under section
 21 ~~406~~ 405(b).

22 **“SEC. ~~406~~405. GOAL AND DUTIES OF THE COMMISSION.**

23 “(a) GOAL.—The goal of the Commission is to pro-
 24 tect and restore the marine waters, habitats, and species

1 of the Northwest Straits region to achieve ecosystem
2 health and sustainable resource use by—

3 “(1) designing and recommending projects that
4 are driven by the best available science, local prior-
5 ities, community-based decisions, and the ability to
6 measure results;

7 “(2) building awareness and stewardship and
8 making recommendations to improve the health of
9 the marine resources of the Northwest Straits re-
10 gion;

11 “(3) maintaining and expanding diverse mem-
12 bership and collaboration with partner organizations,
13 such as the Puget Sound Partnership;

14 “(4) expanding partnerships with Tribal gov-
15 ernments and continuing to support Tribal treaties,
16 cultures, and subsistence and Tribal treaty rights;
17 and

18 “(5) recognizing the importance of economic
19 and social benefits that are dependent on marine en-
20 vironments and sustainable marine resources.

21 “(b) DUTIES.—The duties of the Commission are the
22 following:

23 “(1) To provide resources and technical support
24 for marine resources committees.

1 “(2) To work with such marine resources com-
2 mittees and appropriate entities of Federal, State,
3 and local governments and Tribal governments to
4 provide advice in developing regional programs to
5 monitor the overall health of the marine ecosystem
6 of the Northwest Straits region.

7 “(3) To collect marine resources data and iden-
8 tify factors adversely affecting or preventing the res-
9 toration of the health of the marine ecosystem and
10 coastal economies of the Northwest Straits region to
11 inform decisionmakers.

12 “(4) To develop scientifically sound restoration
13 and protection recommendations, informed by local
14 priorities, that address such factors.

15 “(5) To serve as a public forum for the infor-
16 mal discussion of policies and actions, with respect
17 to the marine ecosystem of the Northwest Straits re-
18 gion, of Federal, State, or local governments, Tribal
19 governments, or the Government of Canada.

20 “(6) To inform appropriate authorities and
21 local communities about the marine ecosystem of the
22 Northwest Straits region and about issues relating
23 to the marine ecosystem of the Northwest Straits re-
24 gion.

1 “(7) To consult with all affected Tribal govern-
 2 ments in the Northwest Straits region to ensure that
 3 the work of the Commission does not violate Tribal
 4 treaty rights.

5 “(c) COORDINATION AND COLLABORATION.—The
 6 Commission—

7 “(1) shall carry out the duties described in sub-
 8 section (b) in coordination and collaboration, as ap-
 9 propriate, with Federal, State, and local govern-
 10 ments and Tribal governments, including by—

11 “(A) providing technical support and as-
 12 sistance to any Tribal government seeking rep-
 13 resentation and participation on the Commis-
 14 sion; and

15 “(B) supporting the work and duties of the
 16 liaison to the Commission under section ~~405~~
 17 404(e); and

18 “(2) may enter into cooperative agreements
 19 with nonprofit entities, such as the Northwest
 20 Straits Foundation, to provide assistance, including
 21 financial assistance, in carrying out the duties de-
 22 scribed in subsection (b).

23 “(d) LIMITATIONS.—Nothing in this title provides
 24 the Commission with authority to issue regulations or im-
 25 plement any Federal law or regulation.

1 “(e) ACCEPTANCE OF DONATIONS.—For purposes of
 2 carrying out this section, the Commission may solicit, ac-
 3 cept, receive, hold, administer, and use gifts, devises, and
 4 bequests without any further approval or administrative
 5 action.

6 “(f) ANNUAL REPORT.—

7 “(1) IN GENERAL.—Each year, the Commission
 8 shall prepare, submit to the Committee on Com-
 9 merce, Science, and Transportation and the Com-
 10 mittee on Appropriations of the Senate, the Com-
 11 mittee on Natural Resources and the Committee on
 12 Appropriations of the House of Representatives, and
 13 the Under Secretary, and make available to the pub-
 14 lic a report describing—

15 “(A) the activities carried out by the Com-
 16 mission during the preceding year; and

17 “(B) the progress in achieving the bench-
 18 marks described in paragraph (2).

19 “(2) BENCHMARKS.—The benchmarks de-
 20 scribed in this paragraph are the following:

21 “(A) Protection and restoration of marine,
 22 coastal, and nearshore habitats within the
 23 Northwest Straits region.

1 “(B) Protection and restoration of marine
2 resources populations to healthy, sustainable
3 levels.

4 “(C) Improvement of the water quality of
5 the Northwest Straits region.

6 “(D) Collection of high-quality data and
7 promotion of the use and dissemination of such
8 data for the purposes of ecosystem monitoring.

9 “(E) Promotion of stewardship and under-
10 standing of marine resources of the Northwest
11 Straits region through education and outreach,
12 including by targeted outreach to
13 underresourced communities.

14 **“SEC. ~~407406~~. FUNDING.**

15 “(a) AUTHORIZATION OF APPROPRIATIONS.—There
16 are authorized to be appropriated to the Under Secretary
17 such sums as may be necessary to carry out this title, in-
18 cluding to be made available to the Commission to carry
19 out the duties of the Commission under this title.

20 “(b) ASSISTANCE.—

21 “(1) IN GENERAL.—The Under Secretary may,
22 from amounts made available to the Under Sec-
23 retary to carry out this title, provide assistance to
24 the Commission in carrying out the duties of the
25 Commission under this title.

1 “(2) PROVISION.—The Under Secretary may
 2 provide the assistance described in paragraph (1),
 3 and make available amounts to the Commission to
 4 carry out the duties of the Commission, through a
 5 contract with the Director of the Padilla Bay Na-
 6 tional Estuarine Research Reserve, unless the Gov-
 7 ernor of the State of Washington objects. If such
 8 Governor so objects, the Under Secretary may pro-
 9 vide such assistance and make available such
 10 amounts to the Commission.”.

11 **SEC. 3. NORTH PACIFIC RESEARCH BOARD ENHANCEMENT.**

12 (a) *SHORT TITLE.*—*This section may be cited as the*
 13 *“North Pacific Research Board Enhancement Act”.*

14 (b) *NORTH PACIFIC RESEARCH BOARD ENHANCE-*
 15 *MENT.*—*Section 401(e) of Public Law 105–83 (111 Stat.*
 16 *1608; 43 U.S.C. 1474d) is amended—*

17 (1) *in paragraph (3)—*

18 (A) *in subparagraph (L), by striking “and”*
 19 *after the semicolon;*

20 (B) *in subparagraph (M), by striking the*
 21 *period at the end and inserting a semicolon;*

22 (C) *in subparagraph (N), by striking the*
 23 *period at the end and inserting “; and”;*

24 (D) *by inserting after subparagraph (N) the*
 25 *following:*

1 “(O) one member who shall represent Alaska Na-
2 tives and possesses personal knowledge of, and direct
3 experience with, subsistence uses and shall be nomi-
4 nated by the Board and appointed by the Secretary.”;
5 and

6 (E) by adding at the end the following:

7 “Board members appointed under subparagraphs
8 (N) and (O) shall serve for 3-year terms, and
9 may be reappointed once.”; and

10 (2) in paragraph (4)(B), by striking “Not more
11 than 15 percent of the funds provided to the Secretary
12 of Commerce under paragraph (1) may be used to
13 provide support for the Board and administer grants
14 under this subsection.” and inserting “The funds pro-
15 vided to the Secretary of Commerce under paragraph
16 (1) may be used to provide support for the Board and
17 administer grants under this subsection. The Board
18 shall maximize the percentage of funds directed to re-
19 search and maintain the highest quality standards in
20 administering grants under this subsection. On the
21 date that is 5 years after the date of enactment of the
22 North Pacific Research Board Enhancement Act, not
23 more than 15 percent of the funds provided to the
24 Secretary of Commerce under paragraph (1) may be

- 2 *grants under this subsection.”.*
