Nathan and Mary Johnson's house was the first home that Frederick Douglass lived in after escaping slavery in Maryland in 1838. It was at this house that Douglass changed his name from Frederick Augustus Washington Bailey to Frederick Douglass, and it was in New Bedford where Frederick Douglass and his wife, Anna, started their family and Douglass earned his first wages as a freeman.

On June 23, 2023, a ribbon cutting ceremony will be held to celebrate the opening of Abolition Row Park and to commemorate the new local Abolition Row Historical District, which includes four blocks of historic buildings, many of which were the homes of critical anti-slavery advocates leading up to the civil war. The Abolition Row Park will also include a seven-foot statue of Frederick Douglass, who spent his first years of freedom right across the street from that very park.

#### RECOGNIZING THE 59TH ANNIVER- SARY OF THE 1964 MARSHALLS CREEK EXPLOSION

Mr. CARTWRIGHT. Mr. Speaker, today I recognize a significant milestone in the history of our region. June 26, 2023 marked the 59th anniversary of the Marshalls Creek Explosion in Middle Smithfield Township, Monroe County, Pennsylvania.

On June 26, 1964, the Marshalls Creek Fire Company responded to a tractor trailer fire on State Route 209. Shortly thereafter, the trailer exploded killing firefighters F. Earl Miller, Leonard Mosier and Edward Hines. Three passersby also died: John Regina, Joseph J. Horvath Jr., and Lillian Paesch. The explosion also injured 10 other people, caused damage to the Regina Hotel, Middle Smithfield Elementary School, and the Pocono Reptile Farm.

After our community endured the chaos of the explosion, it was discovered that the tractor trailer had no identification placard reporting its explosive contents. During numerous Congressional hearings, the Marshalls Creek Explosion served as a catalyst for remarks concerning increased traffic safety measures and inspections. The concerns expressed ultimately became law with the enactment of the Transportation Safety Act of 1974 and further development of the Emergency Response Guidebook, which is widely used as a resource by Fire Responders across North America.

Today, 59 years later, the Middle Smithfield Township community comes together to dedi-

cate a historical marker at Regina Farms, across from where the explosion occurred. The business is owned by Ed Regina, brother of the late John Regina. This marker will help preserve a piece of history of the community and continue to educate future visitors of the site.

Mr. Speaker, I ask my colleagues to join me in recognizing the 59th anniversary of the 1964 Marshalls Creek Explosion to acknowledge the importance and impact that this event has had on the families of those killed in the explosion, Middle Smithfield Township, and traffic and transportation safety across the Nation.

He received his early fruits of knowledge in the public-school systems of Atlanta, Camilla and Moultrie, Georgia. Following high school, Billy matriculated at the Agricultural and Technical College of Greensboro, North Carolina where he majored in Business Administration. He then attended Atlanta College of Mortuary Science and upon completion returned to his hometown roots in Camilla to operate a family-owned business.

A licensed funeral director and embalmer, Billy used his stewardship of the Robert Jester Mortuary to serve and comfort thousands of families during their times of bereavement. He and the entire staff did whatever it took to support the needs of those who entrusted Robert Jester Mortuary with the care of their dearly departed loved ones. He was a longtime member of the Georgia Funeral Services Practitioners Association, Inc. where he served as President from 1982 to 1984. He was chosen 4th District Mortician of the Year in 1972 and selected as Mortician of the year in 1988 by Alpha Gamma Chapter of Epsilon Nu Delta Mortuary Fraternity, Inc.

It has been said that "Service is the rent we pay for the space we occupy on this earth." Billy Carroll paid his rent, and he paid it well! He gave his time, talent and treasure to numerous social and civic organizations to include City of Camilla Zoning Board; Mitchell County Hospital Endowment Board; Camilla Chamber of Commerce; Kiwanis Club of Mitchell County; NAACP; and Boys and Girls Club; to name a few. He was appointed by Gov. George Busbee to serve on the Georgia State Commission on Indian Affairs and by Gov. Joe Frank Harris to serve on the Governor's Education Review Commission. He

was politically astute, active, a trail blazer and was the first African American to run for City Commissioner in Camilla, Georgia. He received the Living History Award in 2009, the Great Man Award in 2017 and was honored by the Southern Poverty Law Center, the Georgia Department of Public Safety and was nominated by the African American Funeral Services Museum for the Hall of Fame.

A faithful man of God, Billy was an active member of Saint Peter AME Church where he was both a Steward and Trustee.

Billy accomplished much in his life, but none of it would have been possible without the grace of God, the love and support of his beloved wife, Naomi, and his two children, William Carroll, Jr., and Vinai Carroll English.

On a personal note, Billy was my friend and longtime supporter. Over the years he gave me wise and sage counsel, for which I will be forever grateful. Likewise, during his life he did so much for so many for so long. He touched countless lives and because he did, the world is a better place.

#### INTRODUCTION OF THE DISTRICT OF COLUMBIA FEDERAL JUDICIAL OFFICIALS RESIDENCY EQUALITY ACT

Ms. NORTON. Mr. Speaker, today, I introduce the District of Columbia Federal Judicial Officials Residency Equality Act, which would require the federal district court judges, federal circuit court judges, U.S. Attorney, U.S. Marshals and federal court clerk appointed to serve D.C. to reside in D.C. In nearly every other jurisdiction in the United States, such officials are required by federal law to reside in the jurisdiction they have been appointed to serve. The only exceptions are the U.S. Attorney and U.S. Marshal for the Northern Mariana Islands who at the same time are serving in the same capacity in another jurisdiction, and officials appointed to the Southern District of New York and the Eastern District of New York, which are the only districts in different parts of the same city.

The requirement that these federal officials reside in the jurisdiction they serve is related to knowledge of the community and to the effect of decisions. As stated in the official commentary to the Code of Conduct for United States Judges, "a judge should not become isolated from the society in which the judge lives." The same holds true for other federal officials. This bill recognizes that D.C. deserves federal officials with the same understanding and links to the community as Congress has seen fit to require for federal officials in other jurisdictions.

I urge my colleagues to support this bill.

Mr. BEYER. Mr. Speaker, to accompany the introduction of H.J. Res. 76, I am including in the RECORD statements and letters of support for the Redesignation of Arlington House from the descendants of the estate.

CONGRESSMAN BEYER: I am writing to express my support for the redesignation of the National Park Service site currently known as 'Arlington House, the Robert E. Lee Memorial' as the 'Arlington House National Historic Site.'

The memorial to Lee was established in two pieces of legislation 18 years apart. Public Law 84-1071, passed in June 1955, dedicated the memorial and stated that "Lee, whose name will ever be bright in our history as a great military leader, a great educator, and a great American." It went on to say that "he was a truly great man through the simple heritage of his personal traits of high character, his grandeur of soul, and his unflinching strength of heart." The 1972 legislation established public law 92-333 which gave the site its current name, 'Arlington House, the Robert E. Lee Memorial'.

I continue believe this redesignation is long overdue. The name Arlington House National Historic Site is not only inclusive, it is consistent with how the National Park Service manages and interprets this iconic, historic property.

I am a descendant and historian of the Syphax family. Syphaxes were enslaved on the Arlington House plantation by both Robert E. Lee and George Washington Parke Custis before him. Although I disagree with how the earlier legislation characterizes Lee, I disparage neither Lee nor the Custises. I do, however, work hard to give agency to the Syphaxes and all of the Arlington House plantation enslaved community. Their lives and stories are equally as important to the history of this site as is those who enslaved them. Their stories are educational, inspiring and uplifting. Their stories are intertwined with the Lees and Custises. The stories and history told completely can help our country better understand slavery at the Arlington House plantation and have the ability to help generate important and necessary conversations that can help repair and heal from a painful, divisive past.

This redesignation is important to the entire country, not just Arlington House de-

scendant families, the state of Virginia and Washington, D.C. It is important to all Americans. During the short time our on line petition (RedesignateARHO.org) has been collecting signatures, citizens from every state in the country and 9 other nations have expressed their support for the site redesignation.

I live in Loudoun County, VA. I intend to share this message with my own elected officials. Your colleague, Representative Jennifer Wexton, and Senator Tim Kaine, have both co-sponsored and sponsored legislation in the House and Senate, respectively. In addition, I will attempt to seek the support of Senator Mark Warner as a co-sponsor of the Senate legislation.

The name 'Arlington House, National Historic Site' is much more appropriate, accurate, inclusive, and consistent with how the National Park Service manages and interprets historic properties.

As a direct descendant of George Washington Parke Custis and the great-granddaughter of Robert E. Lee. I own over 100 artifacts currently on display in the mansion and the museum—portraits, furniture, silver, documents, and ephemera. It has always been important to my branch of the Custis/Lee family to maintain close ties to Arlington House, despite our tragic history. Over the last 100 years, we have sought to provide a context for learning about the complicated history of the estate, in the hopes that visitors will be able to experience the house as more than just a mausoleum.

With the generous grant from David Rubenstein, the National Park Service has been able to update their interpretation of the site to include the perspectives of the enslaved who built and worked the plantation. The work that has been done here has been exemplary, and other institutions have taken note.

I have also been a member of the Family Circle of descendants of the enslaved and enslavers for more than a year, and although I was prevented from attending the reunion in April by health issues, I have found the group to be inspiring in these dark days of American politics. We can use as much thoughtful conversation and reconciliation as possible, and the group has proved to be a model for others who are trying to understand why some of our country's oldest wounds have never healed.

As other descendants have pointed out, this redesignation is important to the entire country and all Americans. In my opinion, this property should never have been named a memorial to Robert E. Lee in the first place—the 1972 legislation is directly related to the cult of the Lost Cause and should be seen as political backlash to desegregation. As Ty Seidule has pointed out in his important study, Robert E. Lee and Me, names matter, and this change is long overdue.

In 2008, she coordinated a Peace Mission to Liberia, West Africa to meet President Ellen Johnson Sirleaf and conducted several workshops aimed at helping to heal trauma of the Liberian Civil War on teen soldiers. She is the author of a book entitled Pathways to Interfaith Dialogue: An Innovative Model for Peace and Community Building. She formerly served as the executive director of Detroit Renaissance District Peace Center at Hope United Methodist Church. As a proud member of Delta Sigma Theta Sorority, Ms. Talley continues to promote their mission of service as a member of the Southfield Alumnae Chapter and as a Delta Dear. She remains active with the Task Force, Hope Church and the sorority. She is also a member of the National Congress of Black Women and Southfield Historical Society.
