

NO STOLEN TRADEMARKS HONORED IN AMERICA ACT OF 2023

Mr. ISSA. Mr. Speaker, recognizing and safeguarding intellectual property rights is a vital interest for the United States and a critical component of our leadership, which has historically championed strong IP rights.

Consistent and strong IP rights ensure that business will seek to innovate in the U.S. and enjoy the protections granted under our Constitution and laws.

It goes without saying that strong IP protections require that the government respect IP ownership and the right of IP owners to control who exercises their rights.

Similarly obvious is that the government should not condone IP theft.

That is exactly what has happened with the trademarks stolen by the Communist government of Cuba.

As if oppressing and brutalizing the Cuban people was not enough, the Castro regime also stole IP from legitimate owners during its vicious takeover of Cuba.

This included stealing valuable trademarks, such as "Havana Club," from the Arechabala family.

The Arechabala family for years invested their time and resources building a world-renowned brand for their rum only to have the Communists steal it along with the rest of their property, including all of their production facilities.

The Castro regime then embarked on decades of exploiting that IP, manufacturing and exporting rum using the "Havana Club" trademark they stole.

The Arechabala family never recovered from what happened to them, but they transferred their rightful interests in their trademarks to the Bacardi family and company in the U.S.

As a world leader when it comes to IP rights, it should be clear that the U.S. government would side with Bacardi in a dispute between them and the Castro regime over these trademarks.

But in 2016, the U.S. Patent and Trademark Office, or USPTO, recognized the Cuban regime's claim on the "Havana Club" trademark even though it was stolen by the Cuban regime.

That is why I introduced this bill, which prohibits the executive branch from recognizing, enforcing, or validating any trademark used in connection with a business or assets that

were confiscated without the consent of the original owner or successor-in-interest.

I was delighted to be joined by my Democratic colleague, Ms. WASSERMAN SCHULTZ of Florida, in introducing it, and the bill has since been cosponsored by 17 other Members from both parties on the way to being overwhelmingly approved by the Judiciary Committee on a bipartisan basis.

We all agree that the U.S. government should not reward those who would steal and exploit trademarks, or any other IP, without the consent of the legitimate owners.

Allowing Cuba to propagate its misappropriation of IP also sets a harmful precedent for international IP protections.

I urge my colleagues on both sides of the aisle to support this legislation.

Over the course of his career. Bill took on numerous high-profile cases. He worked as legal director for the Center for Constitutional Rights, where he represented Guantanamo Bay detainees. Vietnamese survivors of Agent Orange, and the wrongfully detained. He sought to focus his work on the protection of civil liberties. Bill eventually returned to Detroit as partner at the law firm Goodman Hurwitz, where he continued to represent families and individuals who were victims of police and government misconduct.

Bill worked with a number of legal advocacy organizations, including the National Lawyers Guild, ACLU, and Sugar Law Center, where I got to know him when we both served as board members. I knew Bill to be a fierce advocate, a brilliant legal mind, and a tenacious but kind warrior for justice.

Please join me in tribute to Bill Goodman, remembering his life and distinguished career. May he rest in power.

INTRODUCTION OF THE FEDERAL GOVERNMENT ADVERTISING EQUITY ACCOUNTABILITY ACT

Ms. NORTON. Mr. Speaker, today, I introduce the Federal Government Advertising Equity Accountability Act, which would require all federal agencies to include in their annual budget requests to Congress the amount they spend on advertising contracts with small disadvantaged businesses (SDBs) and businesses owned by minorities and women. Federal agencies would be required to provide prior and projected total expenditures for such contracts. At my request, the Committee on Appropriations has been requiring such information from many agencies for the last several years, but this bill would codify this requirement and apply it to all federal agencies.

In 2007, the Government Accountability Office (GAO) examined spending on advertising contracts with minority-owned businesses by five agencies—the Department of Defense, the Department of the Treasury, the Department of Health and Human Services, the Department of the Interior and the National Aeronautics and Space Administration—and found that only five percent of the \$4.3 billion available for advertising contracts went to minority businesses. In light of these concerning findings, several Members of Congress and I sent letters to GAO in April 2016 and June 2022 requesting updated information on the amount of federal advertising dollars spent with SDBs and businesses owned by minorities and women. A GAO report released in July 2018 showed that in fiscal year 2017, only 16 percent of the federal government's advertising contract obligations went to SDBs and businesses owned by minorities and women. GAO agreed last year to issue an updated report.

The federal government is the largest advertiser in the United States, and it has an obligation to ensure equitable access to its contracts for SDBs and businesses owned by minorities and women. The GAO's findings demonstrate that there is still much progress to be made.

The regular collection of information on federal advertising contracts with SDBs and businesses owned by women and minorities is essential to bridging the gap between what current statistics show and a more inclusive advertising landscape. This bill would help achieve this goal while also promoting transparency and encouraging federal agencies to strive to reach minorities, who often receive the news from smaller media outlets that serve communities of color. The requirement that agencies submit prior and projected information on the amount of advertising dollars spent with SDBs and businesses owned by minorities and women would allow federal agencies to evaluate their progress. The regular collection of this information would also demonstrate that the promotion of equity in advertising, and in all areas of government, is a continuous effort and is important to the mission of every agency.

I urge my colleagues to support this bill.

MARTIN GRUEN'S 101ST BIRTHDAY

Mr. CASTEN. Mr. Speaker, I rise today to celebrate the 101st birthday of Dr. Dieter Martin Gruen for his dedication to science, significant contributions to new energy technologies, and devotion to fighting climate change. For over eight decades, Dr. Gruen has worked to enhance American technology development as a former Manhattan Project Scientist and as an Argonne National Laboratory Distinguished Fellow.

Dr. Gruen's story signifies the American dream. Born in Waldorf, Germany in 1922 to a Jewish family, Dr. Gruen would eventually leave his home only fourteen years later when the Nazi party solidified its power. He was sent to Little Rock, Arkansas to live with relatives to finish up his high school education while his parents were sent to concentration camps. Luckily, his mother and father escaped and Dr. Gruen was reunited with them in Chicago a few years later.

The shock of nearly losing his family did not dissuade Dr. Gruen from dedicating himself to his studies and empirical inquiry. Five years after reuniting with his family, Dr. Gruen received his bachelor's degree in chemistry from Northwestern University in 1944, his master's degree, and eventually a PhD in chemical physics from the University of Chicago. He studied at night and worked at a machine shop during the day. Shortly after graduating from Northwestern University, Dr. Gruen was recruited to work on the Manhattan Project, the U.S. government's top-secret effort to develop the atomic bomb. He worked on the

large-scale electromagnetic separation of uranium-235, and the nuclear material he helped to produce would later be fashioned into the bomb that fell on Hiroshima in 1945.

After the war, Dr. Gruen helped found the Oak Ridge Scientists and Engineers, a group dedicated to ensuring nuclear weapons were never used again in war. After returning home to Chicago, he began working at Argonne National Laboratory, one year after the establishment of the U.S. Department of Energy national laboratories and during a time when Argonne was a national center for the development of nuclear reactors. Dr. Gruens work at Argonne focused on nuclear power and led to him serving as a delegate to the Second United Nations Conference on Peaceful Uses of Atomic Energy in 1958.

Throughout his career, Dr. Gruen has made significant contributions to new energy technologies, specifically to nuclear fission and fusion, solar energy, energy storage, and conservation. Dr. Gruen has been recognized by the international scientific community and has made key advancements such as the nuclear submarine reactor cooling design and purification of uranium used to end World War II in the Pacific theater.

For these accomplishments and his lifelong commitment to science, I had the great honor of supporting Dr. Gruen's nomination for the Presidential Medal of Freedom alongside my colleagues, Representatives BILL FOSTER, FRENCH HILL, Jerry McNerney, and Cheri Bustos. Dr. Gruen's tireless and selfless efforts to solve future clean energy challenges presented by climate change is seldom exhibited by an individual. Humble and unpretentious, Dr. Gruen is the embodiment of a dedicated American and pure scientist.

I have had the great pleasure of learning from Dr. Gruen from his life stories and scientific endeavors in innovation and inquiry. Today, I wish Dr. Gruen a very happy 101st birthday and thank him for his decades of public service and remarkable advancements in and commitment to scientific research and discovery.
