

DEAR REPRESENTATIVES ISSA AND COSTA: On behalf of the U.S. Travel Association (U.S. Travel), which represents all segments of America's travel industry, I am writing to express our strong support for H.R. 6610, the Passport System Reform and Backlog Prevention Act, which is a bipartisan measure that calls for the modernization of the State Department's passport processing capabilities. H.R. 6610 provides a much-needed framework for meeting the Department's commitment to improve efficiency, security, and customer experience within the passport application process.

As you know, America's travel industry plays a vital role in our Nation's economy, contributing significantly to revenue generation and job creation across all 50 states and territories. U.S. Travel's mission is to increase travel to and within the United States, and H.R. 6610 aligns with that mission. As the travel sector continues to recover from the pandemic, there is an urgent need to modernize that travel experience, improve travel IT infrastructure, and position the Department to meet increased demand for passports. In 2022 and 2023, the Department received a record-breaking number of passport applications driven by the surge in U.S. traveler demand for international trips, thereby causing a massive and persistent backlog in average processing times.

While there has been modest improvement in passport processing times since last summer, more needs to be done to bring about sustained progress. Significant improvements in both passport and visa processing times can be readily achieved through the long-overdue modernization of the Bureau of Consular Affairs' outdated IT systems. The legacy systems relied upon by Consular Affairs have significantly hindered the agency's ability to keep pace with demand and disrupted the travel experiences of millions of Americans each year. Accordingly, the modernization of IT infrastructure should be treated as a critical priority for delivering streamlined customer experience for passport and visa applicants, while ensuring the accuracy and security of those functions.

This modernization initiative also aligns with broader efforts to promote international travel and strengthen diplomatic relations. As the world becomes increasingly interconnected, it is essential for the United States to maintain a robust and efficient passport system that facilitates the movement of people and fosters a travel sector that drives economic growth and job creation.

The U.S. Travel Association commends your bipartisan leadership in introducing H.R. 6610 and looks forward to working alongside you to advocate for its passage. Sincerely.

Mr. CARSON. Mr. Speaker, today I rise to honor a Hoosier whose service to country and community has endured for over three decades. Lisa Wilken is a former airman and advocate who has dedicated her career to uplifting her fellow veterans.

Lisa's service began in the United States Air Force and continues today through her work with veteran service organizations as a fierce advocate for veteran-friendly legislation at both the Indiana Statehouse and the United States Congress.

As an active member of multiple veteran organizations, Lisa has advocated for veterans at every stage. Far too often the assistance veterans require post-service is not accessible, or just nonexistent. Lisa's experience in the Air Force enabled her to become an advocate for lifechanging legislation at the Indiana Statehouse, including securing tax exemptions for disabled veterans, Veteran Service Officer accreditation, tuition coverage and free programs for dependents of disabled veterans, and the creation of the State Women Veteran Coordinator position at the Indiana Department of Veteran Affairs.

Lisa has prioritized recognizing and serving overlooked constituencies in the military community, especially women veterans. She testified before Congress to raise awareness for the lack of funding for military sexual trauma veterans. In 2017, she was honored by the State of Indiana with the Torchbearer Award, and in 2023, she was inducted into the Indiana Military Veterans Hall of Fame. Lisa Wilken has established a legacy in the Indianapolis and surrounding communities that will be felt and deeply appreciated for future generations of service women and men.

Even within the veteran community, women veterans tend to be overlooked and underrecognized. That is why I am proud to honor the many Hoosier women veterans who selflessly serve our community. Beginning with its namesake, the Sheila Corcoran Hoosier Women Hero Award was created to highlight exemplary Hoosier women veterans whose service to their community and Nation is unparalleled. I ask my colleagues to join me in recognizing Lisa Wilken. I thank Lisa for her service and for her advocacy as she continues to be a voice of her peers, for her persistence, and for her commitment to the veteran community.

Mr. ROY. Mr. Speaker, I rise today to commemorate the 100th birthday of the Kerrville Veterans Affairs Medical Center in my district. This beautiful campus serves veterans from across multiple counties in the Texas Hill Country.

The Benevolent War Risk Society and the American Legion recognized the need for medical care of World War I veterans. Countless veterans contracted tuberculosis during and after that conflict. Fundraising for the hospital began in 1919. The generous Schreiner family of Kerrville donated over 700 acres of land for the hospital grounds. Unfortunately, funding ran out in early 1921. The American Legion came to the project's rescue and eventually donated the hospital to the State of Texas

As a result, the name "American Legion Memorial Sanatorium" was bequeathed on the facility. The first patients were admitted on June 22, 1921. The federal Veterans Administration began to lease the hospital from the State of Texas two years later. The facility became the 93rd veteran hospital to open in the United States on July 12, 1923, under the name "Veterans Administration Hospital at Kerrville." There were a total of 15 buildings on campus at the time, some of which are still used today.

President Herbert Hoover created the Veterans Administration in July 1930, changing the name of the hospital yet again. Over the

years, efforts were made to expand. A two million-dollar project in 1947 resulted in 400 additional beds and a total of 8 hospital floors. January of 1960 saw the conversion of the facility to full general medical services.

On March 15, 1995, the South Texas Veterans Healthcare System was created when the Kerrville VA Medical Center merged with the Audie L. Murphy Memorial Hospital in San Antonio.

Over the years, the Veterans Administration donated most of the original land to various local entities. The current footprint of the Kerrville VA Medical Center is 70 acres, including a Veterans National Cemetery. My constituents will gather on April 12, 2024 to recognize the significant contributions of this medical facility to Texas veterans.
