Women employed at Melissa's organization have the chance to become artisans, learning everything from jewelry making, candle pouring, order fulfillment, and shipping. They're also taught life skills, such as time management and what it means to work in a healthy environment. Melissa's organizations have grown so big that they're opening a secondary location where they'll also educate the community about the issue of human trafficking and exploitation.

A faithful voter since 1937, Brunette contributes to her community charitably and civically.

A believer that it is "never too late to achieve your dreams", Brunette obtained her driver's license at 50 years old. Growing up in the segregated south, her access to an education beyond the 7th grade was limited. In

her 60's, she enrolled in the 8th grade at a neighborhood school and continued until she graduated with her diploma from Bennett High School, achieving a lifelong dream.

HONORING THE LIFE AND LEGACY  
OF MR. HUGHES VAN ELLIS

Ms. JACKSON LEE. Mr. Speaker, I rise to celebrate, cherish, and honor the extraordinary life of Hughes Van Ellis, who was born in 1921 in the Greenwood District of Tulsa, Oklahoma—one of the flashpoints of the modern Civil Rights Movement.

He, alongside his sister Viola Fletcher, was one of the last surviving witnesses of the Tulsa Race Massacre.

At the time of his birth, the Greenwood District of Tulsa was a thriving community built up by its Black residents into a nationally renowned entrepreneurial center known as "Black Wall Street."

In 1921, white supremacy and racist violence were common throughout the United States and went largely unchecked by the justice system.

On the morning of May 30, 1921, Mr. Van Ellis and the other residents of Greenwood District had their world shattered when reports of an alleged and disputed incident between a young Black man and a young white woman gave the white community of Tulsa a pretext for violently attacking the prosperous Black community.

The Tulsa Tribune called for a lynching amidst a climate of white racial hostility and white resentment over Black economic success.

On May 31, 1921, a mob of armed white men descended upon Tulsa's Greenwood District and initiated the unchecked violence known today as the "Tulsa Race Massacre."

Tulsa municipal and county authorities failed to take action to protect the Black community, nor did they attempt to calm or contain the violence.

Law enforcement officials deputized many white men who were participants in the violence as their agents.

In just 24 hours, the white mob's violence led to the death of an estimated 300 Black residents, as well as over 800 injuries.

The white mob looted, damaged, burned, or otherwise destroyed approximately 40 square blocks of Black Wall Street in Greenwood District of Tulsa Oklahoma, which included an estimated 1256 homes of Black residents and virtually every other structure, including churches, schools, businesses, a hospital and a library.

Nearly 9,000 Black Tulsans were left homeless and suffered over \$200 million dollars in losses.

In the wake of the Tulsa Race Massacre, the Governor of Oklahoma declared martial law and units of the Oklahoma National Guard participated in the mass arrests of nearly all of Greenwood's surviving men, women, and children, removing them from Greenwood and unlawfully detaining them in holding centers.

Oklahoma local and state governments dismissed and distorted claims surrounding the 1921 Tulsa Race Massacre for decades and the event was effectively erased from collective memory and history.

The final injury to Black residents was that insurance companies refused to pay claims for the losses they suffered to the homes and businesses that had been looted or destroyed.

Mr. Van Ellis dedicated his life to ensuring that this atrocity would not be forgotten and to the pursuit of justice for survivors.

Through it all, his love of country shown through his service as a World War II veteran, fighting for our Nation's freedom.

When he returned home, he continued to serve as a soldier in the fight for civil rights, truth, and justice.

He started a family with his wife, raising their seven children, while working as a sharecropper, mechanic, janitor, gardener, and a gas station attendant.

In 2021, Mr. Van Ellis bravely sat before the United States House Judiciary Committee and testified to the dangers of structural racism and inequality.

He drew attention to the abdication of responsibility by government and city officials to rebuild and repair the Greenwood community and testified to the government on the active blocking of recovery efforts by city officials.

Alongside fellow survivors, he demanded that the government not forget about what happened in Tulsa and that the survivors should receive reparations for the trauma they endured.

He was a vocal and staunch advocate for the enactment of H.R. 40, the Commission to Study and Develop Reparation Proposals for African Americans Act, to address injury caused to the descendants of the formerly enslaved.

He encouraged all people in the United States to reflect upon the history of the United States as an imperfect but committed journey to establish a more perfect union and to cherish and exercise the rights, privileges, and responsibilities guaranteed by the Constitution.

Above all, Hughes Van Ellis refused to sit by quietly as a piece of his life was wiped from public memory as well as the history books.

His staunch advocacy for justice and civil rights won over the hearts and minds of millions to his cause, passing on his determination to redress for the wrongs of the past.

Hughes Van Ellis is survived by his daughters Malee V. Craft and Muriel Ellis Watson, as well as his sister and fellow survivor Viola Ford Fletcher.

On behalf of the constituents of the 18th Congressional District of Texas, I take great pride in recognizing Hughes Van Ellis on a meaningful and prosperous life.

Jackie's journey began in the 1970s when, as a show business journalist, she interviewed stars like Elvis Presley, Frank Sinatra, and the Rolling Stones. In 1977, she began her focus on sports after interviewing Thomas Hearns, then a boxing prospect from the Kronk gym in Detroit. From there, she would serve as Hearns' publicist over the next decade and became a familiar name in Detroit's competitive boxing scene.

Professor Whelan was also a friend and mentor to students—she led several foreign study programs and provided guidance and personal friendship to her students. She cared about her students, and over thirty years later, her students still care for her.

## HONORING DR. YANG DAO

Ms. MCCOLLUM. Mr. Speaker, I rise today to recognize and congratulate Dr. Yang Dao for a lifetime of achievements spanning over five decades of public service and community contributions to the multi-Lao ethnic people of Laos and the Hmong American Diaspora community in the United States and beyond. Born on September 7, 1943, to Yang Mi Nou and Her Kei in the Xieng Khouang Province during the Royal Kingdom of Laos, Dr. Yang Dao was educated in the time of the French colonial administration of Indochina, received a high school diploma in June 1964, and graduated with a bachelor's degree (baccalaureate française) from the University of Paris in 1968. With funding support from the United Nations Educational, Scientific and Cultural Organization (UNESCO), Dr. Yang Dao went on to complete a doctoral program in 1972, becoming the first Hmong in history to receive a PhD in Social Science from The Sorbonne University in France.

After completing his graduate studies, Dr. Yang Dao returned to the Royal Kingdom of Laos to serve the government in many important roles, including as the Director of Human Resources in the Ministry of Planning from 1972 to 1974, and was later appointed by the King of Laos, His Majesty King Sisavang Vatthana as a member of the National Political Consultative Council (National Assembly) from 1974 to 1975 during the last unity coalition government consisting of the Royalist and Neo Lao Hat Sak (Pathet Lao) political factions.

The fall of Laos to the communist Pathet Lao in May 1975 forced hundreds of thousands of Lao, Hmong, and other multi-ethnic

refugees to flee to the neighboring country Thailand by crossing the mighty Mekong River, where Dr. Yang Dao and his family joined the exodus of refugees in seeking safety. In July 1976, Dr. Yang Dao's family resettled to France and later migrated to the State of Minnesota (USA) in 1983.

Upon his arrival in the United States, Dr. Yang Dao joined the faculty at the University of Minnesota Twin Cities Campus as an Adjunct Professor teaching Southeast Asian Anthropology and History. He went on to teach at many local Twin Cities higher education institutions including Hamline University, and Metropolitan State University. Throughout his career, Dr. Yang Dao has authored many books, including Hmong History, Culture, and Spirituality at a Glance Through Speeches released in 2023, Hmong at the Turning Point (1993—French and English), and first Hmong-French Dictionary (1964). He has also co-authored many books and has written extensively in academic periodicals and Journals.

Dr. Yang Dao is also a well-known public speaker who has participated in many national and international conferences in the United States, France, Laos, Thailand, Vietnam and China. He speaks Hmong, Lao, French, English, Thai, Vietnamese and Cantonese (Chinese). Dr. Yang Dao is also a prolific artist and composer who has created albums and popular songs from Sib Pab Ciaj Vaj (Hmong unity) to Nkauj Hnub Twj Tuaj Ci lab (Hmong face a bright new dawn).

As one of the very few surviving officials of the Royal Lao government, Dr. Yang Dao is still very active in civic engagement, frequently traveling internationally to foster public diplomacy by promoting peace and encouraging educational and cultural exchanges.

Mr. Speaker, please join me in this well-deserved tribute to Dr. Yang Dao, for his lifetime of service to Hmong Americans in Minnesota and across the United States of America.

#### HONORING THE EXTRAORDINARY LIFE AND LEGACY OF MRS. MYRNA JACKSON

Ms. SEWELL. Mr. Speaker, I rise to honor the extraordinary life and legacy of Mrs. Myrna Carter Jackson, a civil rights activist and community leader in Birmingham, Alabama, who passed away on May 31, 2024, at the age of 82.

Mrs. Jackson was born on July 9, 1941, in Birmingham, Alabama as one of eight children to the late Willie George Carter and Willie Lee Ledger. After graduating from A.H. Parker High School at the age of sixteen, she attended Barbara Durr Beauty College in 1965 and obtained a license in cosmetology. Later in life, she continued her educational journey at Lawson State Community College and Miles College, graduating with a bachelor's degree in social work in 2000.

Mrs. Jackson became involved in the Civil Rights Movement at an early age, serving as the First Vice President of the Metro Birmingham Branch of NAACP. After the 1963 bombing of the 16th Street Baptist Church, she participated in the Children's March and Monday Masses, organized by the Alabama Christian Movement for Human Rights and Reverend Fred Shuttlesworth. In response to her peaceful demonstration, Mrs. Jackson was jailed twice and spent more than three weeks in the Birmingham Jail. She experienced violence and troubling conditions during her incarceration but drew strength from the support and comradery that she received from other members of the Movement.

A dedicated community leader, Mrs. Jackson's commitment to service was the throughline of her career. She served as a certified substitute teacher for several Birmingham schools, provided social services and workforce development to survivors of Hurricane Katrina, facilitated job training for students through the Birmingham Works for Youth, and served as Commissioner of the Housing Authority of the Birmingham District. As a member of the Top Ladies of Distinction, she worked with Top Teens of America to provide scholarships and funding for students.

Even later in life, Mrs. Jackson's commitment to the ideals of the Civil Rights Movement never wavered. In 2009, she organized a conference with the Birmingham Civil Rights Institute and the FBI to promote healthy dialogue between youth and law enforcement. In 2017, she helped commemorate the Birmingham Civil Rights National Monument and went on to serve as the Interim President for the Metro Birmingham Branch of the NAACP.

Mrs. Jackson received much recognition for her remarkable leadership and contributions to the Civil Rights Movement. She was honored by the Metro Birmingham Branch of the NAACP in 2013 for the 50th anniversary of the Civil Rights Movement. In 2017, she was selected by The HistoryMakers for an oral history interview of her incredible life story.

Mrs. Jackson is preceded in death by her husband, Issic Jackson; parents Willie George Carter and Willie Lee Ledger; and three brothers, Gilbert Carter, Alfred Lee Carter, and John Carter. She is survived by two sons Jeff-

ery Jackson and Michael Jackson; one granddaughter Denitra Streeter; one grandson Kieron Jackson; one brother Willie Carter Jr.; four sisters Sylvia Weatherspoon, Lee Edna Boone, Iris Elom, and Wanda Morton, and a host of cousins, friends, and church members.

On a personal note, Mrs. Jackson was a source of great inspiration for me and so many young Black women. A trailblazer and pioneer, she was devoted to her community, her family, and the power of the Civil Rights and Voting Rights Movement. It is because of the courage, bravery, and strength of Foot Soldiers like Myrna Carter Jackson that we enjoy the freedoms we have today. Her life is a testament to the power of ordinary Americans to achieve extraordinary social change. May we find comfort in knowing that she lived a full and blessed life, and that her legacy will live on in the lives she touched.

Mr. GREEN of Tennessee. Mr. Speaker, I rise today to recognize a dedicated citizen from the greatest generation of Americans, Mrs. Leigh Walker.

Mrs. Walker represents the best of patriotism and what it means to be an American. Eighty-three years ago, a fifteen-year-old in California heard a call to help her country. Pearl Harbor had been attacked, the United States entered the war, and women had just begun joining the war effort. Miss Leigh and her mother were two of the many civilians who reported for duty. Women across the country worked long hours and long weeks, including Leigh and her mother. After months of training, Miss Leigh became a certified welder and began working on ships in Richmond, California at only sixteen years old.

The SS *Red Oak Victory*, a ship named for the small town in Iowa, was among the ships Mrs. Walker remembers working on. Built to last, this naval ship is still docked in Richmond today. Now no longer used for war, it is a testament to the skill and perseverance exempli-

fied by young women during the war. Miss Leigh and many of her peers rose to the occasion and served their country well with strength and dedication.

After the war, Leigh married Leland Walker, who was a highly skilled steamfitter and boiler-maker. Together they moved across the country to Tennessee, which is still their home over 70 years later. Together, they raised two children: Jerry Walker, who served in the U.S. Army during the Vietnam War, and Marcia Chandler, an elementary school teacher of 46 years. Mrs. Walker and the late Mr. Walker have four grandchildren.

Leigh Walker served her community in many informal ways as well. Mrs. Walker spent nearly twenty years helping her daughter's students with reading and writing. She was a reliable volunteer at the high school baseball games where her son-in-law coached and spent many years making cakes treasured by her community for various events.

Today, she is 97 years old and still resides in Dickson County, Tennessee. The advice she leaves speaks to her legacy, "Be honest, love your family, and always vote."

Mr. KILMER. Mr. Speaker, I rise today to honor the life and legacy of Mr. John Brewer. A passionate journalist and dedicated community leader, John passed away in mid-April.

I got to know John when I first ran for Congress back in 2012. From the first moments I spent with him, I learned just how deeply he cared about his community, and his passion for local journalism.

John was the consummate newsman and dedicated his professional career to the field of journalism. His first job was with the weekly Upland News in his hometown of Upland, California in 1965. From there, he went on to work with The Associated Press for 19 years as a reporter, editor, bureau chief, and executive in Seattle, Los Angeles, and New York.

As the Seattle bureau chief, he oversaw the coverage of the devastating 1980 eruption of Mount St. Helens. In Los Angeles, he oversaw the coverage of the 1984 Summer Olympics. During his 10 years as president, CEO, and editor-in-chief of The New York Times Syndication Sales Corp., he enlisted high-profile columnists, including Mikhail Gorbachev, Martha Stewart, and former President Jimmy Carter.

After a prolific career around the country, John joined the Peninsula Daily News in 1998, where he championed local journalism until his retirement in 2015.

John was heavily involved in his community in the North Olympic Peninsula, supporting over 25 nonprofits and other organizations, including the Port Angeles Downtown Association, Community Multicultural Alliance, and Peninsula Home Fund. He served on several

community boards and was a past president of Allied Daily Newspapers of Washington, a statewide press association.

Mr. Speaker, I join our communities of Clallam and Jefferson counties in grieving the loss of a pillar of the community, passionate and dedicated journalist, and compassionate father, brother, husband, and friend. I join John's wife, Barbara, his two sons, and the rest of his family in grieving this sudden and tragic loss.

Mr. Speaker, I recognize that journalism, not just at the local level, but across the country, is better because of the dedicated work and passion of Mr. John Brewer. His impact and legacy will be felt in Port Angeles and the broader Washington State community for many, many years to come.

Gene, like many from the "Greatest Generation" wanted to begin his military career before reaching enlistment age but had to wait and finally enlisted in the Coast Guard in 1942. Gene served in the Coast Guard until 1945, where he attained the rank of Quartermaster First Class. For his service, he earned an American Campaign Medal, an Asiatic-Pacific Campaign Medal, a Good Conduct Medal, a

World War II Victory Medal, and a Philippine Liberation Medal.

Previous to his enlistment, Gene worked as a printer by day and attended trade school by night in Brooklyn, New York. After his military service, Gene started his own printing business in Elmont, New York. Gene owned Gerrard Printing from 1951 to 1965, and St. Gerrard Printing in Port Jefferson Station, New York, from 1965 to 2013.

Gene was also a dedicated public servant, having been elected as town councilman for 22 years. Gene also contributed to the Mount Sinai Fire Department for 50 years as its chief, chaplain, and fire police captain. He founded the Mt. Sinai Fire Department Benevolent Association and the Brookhaven Volunteer Firefighters Museum.

Currently, Gene resides in the Town of Canandaigua in Ontario County, New York with his daughter, Pam Rushack. At 102 years old, Gene still gives back to the community by attending events, giving invocations, and leading in the Pledge of Allegiance. Most notably, Gene has served as a Red Coat Ambassador to the Canandaigua VA, where he has done so the last seven years.

Gene Gerrard is an exceptional community member whose devotion to his country and his community is truly inspiring. It brings me great joy to know Gene. I am thrilled to recognize him for his many accomplishments and wish him a very happy 102nd birthday.
