The flight will benefit 8-year-old Luna D. of Las Vegas, who was diagnosed with an optic glioma tumor in May 2017. Luna travels to Primary Children's Hospital in Salt Lake City, Utah, every three months for specialized oncology care, testing, and an MRI. Before boarding the flight, Luna and her family will get a big sendoff from the Miracle Flights team at Harry Reid International Airport.

This monumental achievement is not only a testament to Miracle Flights' enduring dedication to families in Clark County and Nevada's First Congressional District, but it also reflects its nationwide impact on reducing barriers to essential healthcare.

Since its founding in 1999, UpValley Family Centers has worked to support working families in the greater Calistoga and St. Helena area. UpValley Family Centers is an organization committed to offering prevention and intervention services at a local level. It generously serves our community with time and the monev it raises.

UpValley Family Centers' 25 years of service have been commendable. They serve over 4,000 people annually. Last year, 94 percent of those served fell below the median income for Napa County. Sixty percent were women, and 56 percent were Spanish speakers. The family center itself provides a variety of programs: from assisting residents with accessing health insurance and housing resources to playgroups and family support. UpValley also collaborates with over 40 partner organizations to help engage residents and community members as volunteers.

Over their 25 years of service, UpValley Family Centers' programs have made significant longterm impacts. As a Department of Justice recognized organization, UpValley has helped over 2,000 people become U.S. citizens in tandem with the Napa Citizenship Legal Service. They have increased early literacy, socialization, and school readiness skills in over 1,000 children 0-5 through weekly bilingual playgroups. Children participating in their youth mentoring services are more likely to meet requirements needed to attend a 4-vear college. And in 2020, they distributed over \$2.1 million in pandemic and wildfire-related emergency funds, which reached over 300 households.

UpValley Family Centers also participates in broader civic initiatives throughout Napa County. As a part of the Drug-Free Communities Initiative, they partnered with local officials and helped pass social host ordinances in Calistoga and St. Helena. And in 2020, they assisted local messengers and other Napa County-based community organizations to increase participation in the 2020 Census. Napa County saw a 2 percent increase in census participation as a result of their efforts.

Mr. Speaker, we thank UpValley Family Centers for their dedicated service to the Napa County community. Therefore, it is fitting and proper that we honor them here today.

HONORING 75 YEARS OF SOCIAL SCIENCE RESEARCH CONDUCTED BY THE INSTITUTE FOR SOCIAL RESEARCH AT THE UNIVERSITY OF MICHIGAN

Mrs. DINGELL. Mr. Speaker, I rise today to recognize and commend the historic work conducted by the Institute of Social Research, or ISR, at the University of Michigan in the social sciences. As one of the world's largest and oldest academic survey research organizations, the ISR has paved the way for modern social science methods across the globe. Their work is worthy of recognition.

The ISR's founding director, Rensis Likert, creator of the Likert scale, along with six of his colleagues from the Bureau of Agricultural Economics established the institute in 1948. One of the center's first major projects was changing the way they sampled people to conduct polling for the 1948 U.S. presidential election between Harry Truman and Thomas Dewey. While most national polls, using biased methods, predicted a Dewey landslide, the ISR accurately concluded that Harry Truman had a popular advantage.

Currently, the ISR consists of five separate, but interdependent centers, including the Center for Political Studies, Inter-university Consortium for Political and Social Research, Population Studies Center, Research Center for Group Dynamics, and the Survey Research Center. These five centers are home to over 300 professionally acclaimed research scientists ranging from over 20 academic disciplines that focus on the fields of governance, economics, demographics, inequality, health, and sustainability. Some of the institute's major projects include the University of Michigan Consumer Sentiment Index, which has become an industry standard in indicating how American consumers feel about the general economy. The American National Election Studies, founded in 1948 by the ISR, has been the oldest continuous research study

producing high-quality voting and public opinion data in the country. Methods developed at ISR have helped academics, government agencies, and corporations for 75 years learn about how people think and act.

Mr. Speaker, I ask my colleagues to join me today in commending the incredible work conducted by the ISR at the University of Michigan for the past 75 years. Their dedication to continually improving the rigor of the social sciences has made an everlasting impact across Ann Arbor, Michigan, the United States, and the world. Their educational and training programs have influenced the social sciences everywhere. Thousands of researchers who work around the country have had training ISR, and they produce high-quality studies on the full spectrum of human behavior. ISRs impact cannot be overstated, and their work should be celebrated.

Mr. FONG. Mr. Speaker, I rise today to celebrate the 100th Anniversary of Saint George Greek Orthodox Church in Bakersfield, California. As St. George Greek Orthodox Church celebrates a century of faith, heritage, and hope this year, I urge my colleagues to join me in recognizing the history and roots this Church has upheld since its founding.

Bakersfield's Greek Orthodox organized formally after a time when the Greek community experienced ethnic and religious persecution in their homeland and were forced to look for a new home overseas to practice their culture and faith. Many found work building the transcontinental railroad, venturing further and further west until some reached Kern County in the early 20th century. St. George Greek Orthodox Church's precursor community was founded in 1916 under the name Uplift Society Socrates. According to the narrative history of St. George Greek Orthodox Church in these early years. Greek Americans worked to balance two values so characteristic of the American immigrant experience-upholding the faith and customs of their homeland while also adapting to a new life in the United States.

In 1924, Uplift Society Socrates accomplished the former by constructing a modest hall for religious and social gatherings at 401 Truxtun Avenue. This hall became the foundation upon and around where the Bakersfield Greek Orthodox Church community has since grown. By the early 1930s, the Bakersfield Greek Orthodox community had grown to over 200 families, who soon called for the construction of a Church, which was completed in 1932. Also in 1932, the community changed its name to The Hellenic Community of St. George Greek Orthodox Church. Father Vasilios Markopoulos became the community's first official priest in 1944, though four "Pioneer Priests" had been active in the community in the preceding few decades. Unfortunately, the 1952 Kern County earthquake precipitated the demolition of the original hall. As a mark of the faith of the Greek Orthodox community in Bakersfield, the new Church was blessed by the Bishop of the Fourth Diocese of Los Angeles in 1956. St. George Greek Orthodox Church continues to thrive. And it continues to exemplify the role of faith as the heart of such a vibrant community, uniting individuals in love, compassion, and shared purpose.

Mr. Speaker, I congratulate St. George Greek Orthodox Church as it marks its 100th Anniversary, standing as an example of the incredible growth and faith of the Bakersfield community. Generations of Bakersfield Greek Orthodox have worked to ensure that their traditions and sense of community remain strong in the heart of Bakersfield.

In the 1980s he was given the title, "The Vine Whisperer" as Mr. Preciado proved essential when he used his grafting skills to save vineyards during the phylloxera outbreak in Sonoma and Napa Counties. In response, the University of California, Davis invited Mr. Preciado to help identify vines in their vineyards because of his impressive abilities. Mr. Preciado was also recognized for his work in the "Latino Winemakers Oral History Project Collection" of the Smithsonian National Museum of American History Kenneth E. Behring Center.

Mr. Preciado's wife, Gloria, also gives back to the community. Mrs. Preciado was recognized in 2001 by the Dalai Lama for the work she did in the St. Helena community as well as in El Grullo. In Mexico, she worked to help build a local drug and alcohol rehabilitation center and a soup kitchen for underserved children. They charmed audiences across the Philadelphia region with their performances from the 1950s to the 1970s in parades and have since transitioned from marching to performing on a flatbed float in a concert-style format.

In 1981, during Bristol's 300th anniversary, corps alumni proudly paraded through the streets to the delight of the townspeople. In 2004, a grand 80th Anniversary Celebration reunited former members in Bristol. They performed the National Anthem to open Historic Bristol Day and enjoyed a memorable reunion

dinner and other corps activities. In 2005, an E Alumni corps was established and remains active to this day. However, it is set to conclude after their final performance on Saturday, October 19th, 2024, at the All-Fresh Market on Pond St., Bristol (Historic Bristol Day).

A mural commemorating their legacy will be dedicated during the event. The day will culminate with a celebration dinner at Georgine's and a farewell breakfast at the Golden Eagle Diner on Sunday morning at 11 a.m.

We are incredibly grateful for all that Bristol's Bracken American Legion Cadet Junior Drum and Bugle Corps has done for our community, and we proudly pay tribute to an amazing 100 years.

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Brandon Staglin, Garen Staglin, Shannon Staglin, and Shari Staglin, the founders of One Mind, in recognition of the 30th One Mind Music Festival for Brain Health, the organization's annual premier brain health charity event.

One Mind was founded by the Staglins in 1995 to address the gaps they identified in brain health research and patient support in the wake of Garen and Shannon's son, Brandon's, diagnosis of schizophrenia. That same year, the Staglins hosted a small concert fundraiser at their Napa vineyard, to support the burgeoning organization and its ambitious goals. Since this first iteration, the One Mind Music Festival for Brain Health has evolved to become one of the most important fundraising events for brain health in the country, raising over \$600 million over the years to support invaluable research and initiatives revolutionizing the mental health field.

With the money it fundraises through its music festival, One Mind has been able to play an integral role in pushing the brain health field forward. In 2003, One Mind partnered with the National Institute of Mental Health (NIMH) to launch the North American Prodrome Longitudinal Study, leading to the discovery of biomarkers enabling the prediction of psychosis onset in clinical high-risk youth with 70 percent accuracy. One Mind was also the principal fundraiser for the 2021 Ken Burns documentary "Hiding in Plain Sight: Youth Mental Illness", which was screened at the White House and the U.S. Capitol and has aired on 350 PBS stations. Furthermore, One Mind has been instrumental in launching the careers of boundary-pushing scientists with their Rising Star Awards, recognizing the likes of Dr. Kafui Dzirasa, a pioneer of the brain pacemaker, and Dr. Joshua Gordon, the director of NIMH from 2017 to 2024.

Outside of One Mind, the Staglins have continued to commit themselves to lives of service. In 2008, Shari and Garen advocated alongside U.S. Representative Patrick Kennedy to pass the Mental Health Parity and Addiction Equity Act of 2008, a bill mandating fair and equal insurance coverage for physical and mental health. In 2009. Shari, Garen, and Brandon collaborated with actor Glenn Close to launch the nonprofit Bring Change to Mind. an organization dedicated to ending the stigma surrounding mental health. Additionally, Shari and Garen chaired UCLA's Centennial Fundraising Campaign, leading the campaign to raise over \$5.49 billion to support the school and its programs.

Mr. Speaker, the Staglins have left an indelible mark on mental health in this country. Their philanthropic efforts and continued support of scientific innovation in the brain health field through their One Mind organization deserves recognition. The network was established in 1983 by a group of local professionals seeing a gap in access to services for the Spanish-speaking community. In addition to emphasizing collaboration, voluntary civil service, and the value of cultural heritage for Latino communities, the network raises critical funds for Napa County students in their pursuit of higher education.

With a mission of closing the opportunity gap for Napa County's Latino students financial needs, the Napa County Hispanic Network has worked tirelessly to increase access to financial support and scholarship services for graduating high school students in our district. Since its founding, the network has distributed over \$500,000 of academic scholarships to more than 700 Napa County students, with the organization increasing their annual impact each year.

Higher education in the United States has always been heralded as the road to career success and fulfillment for our children. By providing students from our county with scholarship funds that empower that pathway, the network has performed an incredible service to our community.

In 2024, the Napa County Hispanic Network awarded \$41,000 in the form of \$1,000 to \$2,500 scholarships through seven different programs, the largest contributions for a single year to date. As college costs have risen over the years, the network has increased its level of support to help parents navigate the growing financial challenges of sending their children to college and university. Following her participation in U.S. Senator Howard Cannon's successful 1976 campaign, Sara was hired as his Administrative Assistant, her first and only paid position in Nevada politics.

In recent decades, Sara has been instrumental in other Nevada campaigns, including presidential candidates Bill Clinton, Barack Obama, Hillary Clinton, Joe Biden, and Kamala Harris. In addition to her political work, Sara has been involved in numerous community and charitable organizations, including the 1964 founding of Boulder City's Art in the Park, the largest juried art festival in the Southwest with proceeds going towards the Boulder City Hospital Foundation.

The State of Nevada has benefitted tremendously from her work. She is greatly respected, highly admired, and deeply loved by so many. I join my fellow Nevadans in wishing her a Happy One-Hundredth Birthday.

The Sam F. Hamra Center for Justice also was named for his work organizing and serving as the first board chairman of Legal Services of Southern Missouri counties. He and his wife, June, also donated the funds to purchase the land for the Kitchen Homeless Family Shelter on the O'Reilly Campus.

Sam Hamra was a community builder who made an impact on so many aspects of Springfield. He will be greatly missed, but his legacy will live on.
