AN ACT

To amend the Defense Production Act of 1950 to include the Secretary of Agriculture as a member of the Committee on Foreign Investment in the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Agricultural Risk Re-
3 view Act of 2025”.

4 **SEC. 2. INCLUSION OF THE SECRETARY OF AGRICULTURE**
5 **ON THE COMMITTEE ON FOREIGN INVEST-**
6 **MENT IN THE UNITED STATES.**

7 Section 721(k) of the Defense Production Act of
8 1950 (50 U.S.C. 4565(k)) is amended by adding at the
9 end the following:

10 “(8) INCLUSION OF THE SECRETARY OF AGRI-
11 CULTURE.—The Secretary of Agriculture shall be a
12 member of the Committee with respect to a covered
13 transaction that involves—

14 “(A) agricultural land;

15 “(B) agriculture biotechnology; or

16 “(C) the agriculture industry, including ag-
17 ricultural transportation, storage, and proc-
18 essing.”.

19 **SEC. 3. CONSIDERATION OF CERTAIN AGRICULTURAL**
20 **LAND TRANSACTIONS.**

21 Section 721(b)(1) of the Defense Production Act of
22 1950 (50 U.S.C. 4565(b)(1)) is amended by adding at the
23 end the following:

24 “(I) CONSIDERATION OF CERTAIN AGRI-
25 CULTURAL LAND TRANSACTIONS.—

1 “(i) IN GENERAL.—After receiving no-
2 tification from the Secretary of Agriculture
3 of a reportable agricultural land trans-
4 action, the Committee shall determine—

5 “(I) whether the transaction is a
6 covered transaction; and

7 “(II) if the Committee deter-
8 mines that the transaction is a cov-
9 ered transaction, whether the Com-
10 mittee should initiate a review pursu-
11 ant to subparagraph (D), or take an-
12 other action authorized under this sec-
13 tion, with respect to the reportable ag-
14 ricultural land transaction.

15 “(ii) REPORTABLE AGRICULTURAL
16 LAND TRANSACTION.—In this subpara-
17 graph, the term ‘reportable agricultural
18 land transaction’ means a transaction—

19 “(I) that the Secretary of Agri-
20 culture has reason to believe is a cov-
21 ered transaction, based on information
22 from or in cooperation with the intel-
23 ligence community;

24 “(II) that involves the acquisition
25 of an interest in agricultural land by

1 a foreign person of the People’s Re-
2 public of China, the Democratic Peo-
3 ple’s Republic of Korea, the Russian
4 Federation, or the Islamic Republic of
5 Iran; and

6 “(III) with respect to which a
7 person is required to submit a report
8 to the Secretary of Agriculture under
9 section 2(a) of the Agricultural For-
10 eign Investment Disclosure Act of
11 1978.

12 “(iii) SUNSET.—The requirements
13 under this subparagraph shall terminate,
14 with respect to a foreign person of the re-
15 spective foreign country, on the date that
16 the People’s Republic of China, the Demo-
17 cratic People’s Republic of Korea, the Rus-
18 sian Federation, or the Islamic Republic of
19 Iran, as the case may be, is removed from
20 the list of foreign adversaries in section

1 791.4 of title 15, Code of Federal Regula-
2 tions.”.
