A BILL

To amend title 38, United States Code, to make permanent the pilot program authorized by the Communities Helping Invest through Property and Improvements Needed for Veterans Act of 2016, and for other purposes.

3 SECTION 1. SHORT TITLE.

4 *This Act may be cited as the “Communities Helping*
5 *Invest through Property and Improvements Needed for Vet-*
6 *erans Act of 2025” or the “CHIP IN for Veterans Act of*
7 *2025”.*

8 SEC. 2. EXPANDING AND EXTENDING A PILOT PROGRAM ON

10 JOURNAL OF TRANSPORTATION AFFAIRS

11 AND RELATED IMPROVEMENTS.

12 (a) EXPANSION.—

13 (1) *IN GENERAL.*—Section 2 of the Communities
14 Helping Invest through Property and Improvements
15 Needed for Veterans Act of 2016 (Public Law 114–
16 294; 38 U.S.C. 8103 note) is amended, in subsection
17 (a)(1)—

18 (A) in the matter preceding subparagraph

19 (A), by striking “property”; and

“(C) A minor construction, or nonrecurring maintenance, project of the Department.”.

24 (2) CONFORMING AMENDMENTS.—Such section is
25 further amended—

- 1 (A) in subsection (b)—
2 (i) in the heading, by striking “OF
3 PROPERTY”;
4 (ii) in the matter preceding paragraph
5 (1), by striking “the donation of a prop-
6 erty” and inserting “a donation”;
7 (iii) in paragraph (1), by inserting
8 “or project” after “property” each place it
9 appears; and
10 (iv) in paragraph (2), by inserting
11 “project,” after “improvements,”;
12 (B) in subsection (c)—
13 (i) in paragraph (1)—
14 (I) in the matter preceding sub-
15 paragraph (A), by striking “real prop-
16 erty and improvements donated under
17 the pilot program” and inserting “a
18 donation”;
19 (II) in subparagraph (A), by
20 striking “; or” and inserting a semi-
21 colon;
22 (III) in subparagraph (B), by
23 striking the period at the end and in-
24 serting “; or”; and

(IV) by adding at the end the following new subparagraph:

3 “(C) the performance of a minor construc-
4 tion, or nonrecurring maintenance, project of the
5 Department.”;

6 (ii) in paragraph (2)—

(I) in subparagraph (A), by striking “construction of the facility” and inserting “donation”;

(II) in subparagraph (B), by inserting “maintaining,” after “altering,”; and

(III) in subparagraph (C), by striking “construction of the facility” and inserting “donation”;

16 (C) in subsection (e)(1)—

(i) by inserting “alter, maintain,” after “design,” both places it appears;

19 (ii) in subparagraph (A)—

(I) by striking “real property and improvements donated” and inserting “a donation”; and

(II) by striking "of the real property and improvements"; and

8 (b) EXTENSION.—Such section is further amended, in
9 subsection (i), by striking “December 16, 2026” and insert-
10 ing “December 16, 2031”.
