A BILL

To designate six creeks in North Carolina in honor of the lives lost in a plane crash in Carteret County, North Carolina, on February 13, 2022, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Down East Remem-
5 brance Act”.

1 **SEC. 2. DESIGNATION OF CREEKS.**

2 (a) NOAH STYRON CREEK.—The creek located at
3 latitude $34^{\circ}59'49.33''$ N, longitude $76^{\circ}8'42.11''$ W, shall
4 be known and designated as “Noah Styron Creek”.

5 (b) HUNTER PARKS CREEK.—The creek located at
6 latitude $34^{\circ}57'52.85''$ N, longitude $76^{\circ}11'11.25''$ W, shall
7 be known and designated as “Hunter Parks Creek”.

8 (c) KOLE MCINNIS CREEK.—The creek located at
9 latitude $34^{\circ}57'46.30''$ N, longitude $76^{\circ}11'18.18''$ W, shall
10 be known and designated as “Kole McInnis Creek”.

11 (d) STEPHANIE FULCHER CREEK.—The creek lo-
12 cated at latitude $34^{\circ}57'38.08''$ N, longitude $76^{\circ}11'31.18''$
13 W, shall be known and designated as “Stephanie Fulcher
14 Creek”.

15 (e) JACOB TAYLOR CREEK.—The creek located at
16 latitude $34^{\circ}52'43.45''$ N, longitude $76^{\circ}17'41.49''$ W, shall
17 be known and designated as “Jacob Taylor Creek”.

18 (f) DAILY SHEPHERD CREEK.—The creek located at
19 latitude $34^{\circ}52'28.26''$ N, longitude $76^{\circ}17'43.20''$ W, shall
20 be known and designated as “Daily Shepherd Creek”.

21 (g) REFERENCES.—Any reference in any law, regula-
22 tion, document, record, map, or other paper of the United
23 States to a creek described in this section shall be consid-
24 ered a reference to that creek as it is designated under
25 this section.
