A BILL

To allow Federal law enforcement officers to purchase retired
service weapons, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Federal Law Enforce-*
 5 *ment Officer Service Weapon Purchase Act of 2025”.*

6 **SEC. 2. PURCHASE OF RETIRED FIREARMS BY FEDERAL**
 7 **LAW ENFORCEMENT OFFICERS.**

8 *(a) IN GENERAL.—Not later than 1 year after the date*
 9 *of enactment of this Act, the Administrator of General Serv-*
 10 *ices shall establish a program under which a Federal law*
 11 *enforcement officer may purchase a retired firearm from the*
 12 *Federal agency that issued the firearm to such officer.*

13 *(b) LIMITATIONS.—A Federal law enforcement officer*
 14 *may purchase a retired firearm under subsection (a) if—*

15 *(1) the purchase is made during the six-month*
 16 *period beginning on the date the firearm was so re-*
 17 *tired; and*

18 *(2) with respect to such purchase, the officer is*
 19 *in good standing with the Federal agency that em-*
 20 *ployes or employed such officer.*

21 *(c) COST.—A firearm purchased under this section*
 22 *shall be sold at the salvage value for such firearm taking*
 23 *into account the age and condition of the firearm.*

24 *(d) DEFINITIONS.—In this section—*

1 (1) *the term “Federal law enforcement officer”*
2 *has the meaning given that term in section 115(c)(1)*
3 *of title 18, United States Code, and includes a retired*
4 *Federal law enforcement officer;*

5 (2) *the term “firearm” has the meaning given*
6 *that term in section 921(a) of title 18, United States*
7 *Code, excluding any machinegun (as defined in sec-*
8 *tion 921(a)(24) of such title) not lawfully possessed*
9 *before section 922(o) of such title took effect;*

10 (3) *the term “retired firearm” means any fire-*
11 *arm that has been declared surplus by the applicable*
12 *agency; and*

13 (4) *the term “salvage value” means the value of*
14 *an asset after it has become useless to the owner or*
15 *the amount expected to be obtained when a fixed asset*
16 *is disposed of at the end of its useful life.*
