## A BILL

To amend the Homeland Security Act of 2002 to establish a council within the Department of Homeland Security to coordinate departmental efforts to identify, address, and mitigate cross-functional impacts of global climate change with respect to the Department's programs and operations, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Homeland Security

5       Climate Change Coordination Act”.

1   **SEC. 2. DHS CLIMATE COORDINATING COUNCIL.**

2       (a) IN GENERAL.—Subtitle H of Title VIII of the  
3   Homeland Security Act of 2002 (6 U.S.C. 451 et seq.)  
4   is amended by adding at the end the following new section:

5   **“§ 890E. Climate coordinating council.**

6       “(a) ESTABLISHMENT.—There is established in the  
7   Department a council to coordinate departmental efforts  
8   to identify, address, and mitigate cross-functional impacts  
9   of global climate change with respect to the Department’s  
10   programs, operations, missions, assets, and personnel (in  
11   this section referred to as the ‘council’).

12       “(b) SIZE; COMPOSITION.—The council shall be com-  
13   prised of not fewer than 20 members. Such members shall  
14   include senior officials from the following:

15           “(1) The Office for Strategy, Policy, and Plans.

16           “(2) The Office of Regulatory Affairs.

17           “(3) U.S. Customs and Border Protection.

18           “(4) The Officer for Civil Rights and Civil Lib-  
19   erties.

20           “(5) The Federal Emergency Management  
21   Agency.

22           “(6) The Federal Law Enforcement Training  
23   Centers.

24           “(7) The Office of Intelligence and Analysis.

25           “(8) U.S. Immigration and Customs Enforce-  
26   ment.

- 1           “(9) The Management Directorate.
- 2           “(10) The Office of Partnership and Engage-
- 3           ment.
- 4           “(11) The Office of Public Affairs.
- 5           “(12) The Office of Operations Coordination.
- 6           “(13) The Office of Privacy.
- 7           “(14) The Science and Technology Directorate.
- 8           “(15) The Transportation Security Administra-
- 9           tion.
- 10          “(16) The United States Coast Guard.
- 11          “(17) United States Citizenship and Immigra-
- 12          tion Services.
- 13          “(18) The United States Secret Service.
- 14          “(19) Any other office or component of the De-
- 15          partment the Secretary determines appropriate.
- 16          “(c) LEADERSHIP.—The Secretary shall designate a
- 17          senior official from among the entities specified in sub-
- 18          section (b) to lead the council.
- 19          “(d) DUTIES.—The council shall carry out the fol-
- 20          lowing:
- 21          “(1) Identify cross-functional impacts of global
- 22          climate change with respect to the Department’s
- 23          programs, operations, missions, assets, and per-
- 24          sonnel.

1               “(2) Address and mitigate cross-functional im-  
2       pacts of global climate change to the Department by,  
3       among other things, developing risk-based climate  
4       change strategies and frameworks.

5               “(3) Make recommendations, as appropriate,  
6       for organizational and resource realignments, as nec-  
7       essary, to support the Department’s risk-based cli-  
8       mate change strategies and frameworks.

9               “(4) Oversee the implementation of depart-  
10      mental actions as required under Executive Order  
11      14008, Tackling the Climate Crisis at Home and  
12      Abroad, and other related or successor orders.

13               “(e) REPORTS.—Not later than one year after the  
14      date of the enactment of this section and annually there-  
15      after for ten years, the Secretary shall submit to the Com-  
16      mittee on Homeland Security of the House of Representa-  
17      tives and the Committee on Homeland Security and Gov-  
18      ernmental Affairs of the Senate, a report regarding the  
19      actions taken pursuant to this section.”.

20               (b) CLERICAL AMENDMENT.—The table of contents  
21      in section 1(b) of the Homeland Security Act of 2002 is  
22      amended by inserting after item relating to section 890D  
23      the following new item:

“Sec. 890E. Climate coordinating council.”.
