Ms. JACOBS (for herself and Mr. McCAUL) introduced the following bill; which
was referred to the Committee on Foreign Affairs

A BILL

To reauthorize the Global Fragility Act of 2019, and for
other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Global Fragility Reau-
5 thorization Act”.

6 **SEC. 2. ANNUAL GLOBAL FRAGILITY ACT STEERING COM-**
7 **MITTEE MEETING ON POLICY ALIGNMENT.**

8 (a) IN GENERAL.—Section 506 of the Global Fra-
9 gility Act of 2019 (22 U.S.C. 9805) is amended—

10 (1) by striking “Not later than” and inserting

11 “(a) IN GENERAL.—Not later than”; and

1 (2) by adding at the end the following:

2 “(b) ANNUAL MEETINGS.—

3 “(1) IN GENERAL.—The senior Federal officials
4 referred to in paragraph (2) shall convene an annual
5 meeting—

6 “(A) to evaluate the extent to which the
7 strategic approach and objectives of priority
8 country and regional plans described in section
9 506 align to current United States policy prior-
10 ities in the relevant countries and regions;

11 “(B) to assess the elements described in
12 paragraphs (1) through (11) of subsection (a)
13 and consider steps to address any deficiencies
14 in such elements;

15 “(C) to determine any beneficial updates
16 or amendments to the priority country and re-
17 gion plans or United States policy priorities to
18 ensure effective short and long-term alignment;
19 and

20 “(D) to consider any beneficial steps to in-
21 crease alignment of relevant diplomatic, devel-
22 opment, and security assistance and cooperation
23 activities with the objectives of such plans and
24 priorities.

1 “(2) PARTICIPANTS.—Each meeting described
2 in paragraph (1) shall be chaired by a position not
3 lower than the Deputy Secretary of State or the
4 Deputy National Security Advisor and include the
5 participation of—

6 “(A) the Under Secretary of State for Ci-
7 vilian Security, Democracy, and Human Rights;

8 “(B) the Under Secretary of State for Po-
9 litical Affairs;

10 “(C) the Administrator of the United
11 States Agency for International Development
12 (USAID);

13 “(D) the Deputy Administrator of USAID
14 for Policy and Programming;

15 “(E) the Under Secretary of Defense for
16 Policy;

17 “(F) the Under Secretary of the Treasury
18 for International Affairs;

19 “(G) each relevant Assistant Secretary, As-
20 sistant Administrator, National Security Coun-
21 sel Senior Director, and relevant equivalent
22 level official with regional or functional respon-
23 sibility for planning, coordination, or implemen-
24 tation of diplomatic, development, or security

1 cooperation or assistance activities in a priority
 2 country; and

3 “(H) equivalent level participation from all
 4 other relevant Federal departments and agen-
 5 cies with activities relevant to conflict preven-
 6 tion or stabilization in a priority county or re-
 7 gion.”.

8 (b) CONFORMING AMENDMENTS.—The Global Fra-
 9 gility Act of 2019 (22 U.S.C. 9801 et seq.) is amended—

10 (1) in section 507(1), by striking “section 506”
 11 and inserting “section 506(a)”; and

12 (2) in section 508(a), by striking “section 506”
 13 and inserting “section 506(a)”.

14 **SEC. 3. REAUTHORIZATION OF THE PREVENTION AND STA-**
 15 **BILIZATION FUND.**

16 Section 509(a) of the Global Fragility Act of 2019
 17 (22 U.S.C. 9807(a)) is amended—

18 (1) in paragraph (2), by striking “2024” and
 19 inserting “2030”; and

20 (2) in paragraph (3)(A), by adding at the end
 21 the following:

22 “(iii) for administrative and other ex-
 23 penses related to the operation, manage-
 24 ment, and monitoring, evaluation, and
 25 learning for programs and activities related

1 to the implementation of the Global Fra-
2 gility Strategy established pursuant to sec-
3 tion 504, including diplomatic and other
4 operational activities carried out to imple-
5 ment such strategy in countries and re-
6 gions selected by the President, pursuant
7 to section 505(a), notwithstanding any
8 other provision of law.”.

9 **SEC. 4. REAUTHORIZATION OF THE COMPLEX CRISES**
10 **FUND.**

11 Section 509(b)(2) of the Global Fragility Act of 2019
12 (22 U.S.C. 9807) is amended by striking “2024” and in-
13 serting “2030”.

14 **SEC. 5. USE OF ECONOMIC SUPPORT FUND TO SUPPORT**
15 **MONITORING, EVALUATION, AND LEARNING**
16 **ACTIVITIES.**

17 Funds authorized to be appropriated or otherwise
18 made available to carry out chapter 4 of part II of the
19 Foreign Assistance Act of 1961 (22 U.S.C. 2346 et seq.;
20 relating to the Economic Support Fund) are authorized
21 to be made available for monitoring, evaluation, and learn-
22 ing activities in countries and regions selected by the
23 President, pursuant to section 505(a) of the Global Fra-
24 gility Act of 2019 (22 U.S.C. 9804), notwithstanding any
25 other provision of law for any program funded from

1 amounts available for the Prevention and Stabilization
2 Fund established under section 509(a) of such Act (22
3 U.S.C. 9808(a)) in any fiscal year and related programs
4 funded by other agencies to implement the Global Fra-
5 gility Strategy established pursuant to section 504 of such
6 Act (22 U.S.C. 9803).
