A BILL

To require the Securities and Exchange Commission to carry out a study and rulemaking on the definition of the term “small entity” under the securities laws for purposes of chapter 6 of title 5, United States Code, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Small Entity Update*
5 *Act”.*

6 **SEC. 2. STUDIES, REPORTS, AND RULES REGARDING SMALL**
7 **ENTITIES.**

8 (a) *DEFINITIONS.—In this section—*

9 (1) *the term “Commission” means the Securities*
10 *and Exchange Commission; and*

11 (2) *the term “small entity”—*

12 (A) *has the meaning given the term in sec-*
13 *tion 601 of title 5, United States Code, with re-*
14 *spect to the activities of the Commission; and*

15 (B) *includes any definition established by*
16 *the Commission of the term “small business”,*
17 *“small organization”, “small governmental juris-*
18 *isdiction”, or “small entity” under paragraph (3),*
19 *(4), (5), or (6), respectively, of section 601 of*
20 *title 5, United States Code, with respect to the*
21 *activities of the Commission.*

22 (b) *STUDIES AND REPORTS.—Not later than 1 year*
23 *after the date of enactment of this Act, and again 5 years*
24 *thereafter, the Commission shall—*

1 (1) *conduct a study of the definition of the term*
2 *“small entity” with respect to the activities of the*
3 *Commission for the purposes of chapter 6 of title 5,*
4 *United States Code, which shall consider—*

5 (A) *the extent to which the definition of the*
6 *term “small entity”, as in effect during the pe-*
7 *riod in which the study is conducted, aligns with*
8 *the findings and declarations made under section*
9 *2(a) of the Regulatory Flexibility Act (5 U.S.C.*
10 *601 note);*

11 (B) *the amount by which financial markets*
12 *in the United States have grown since the last*
13 *time the Commission amended the definition of*
14 *the term “small entity”, if applicable; and*

15 (C) *how the Commission should define the*
16 *term “small entity” to ensure that a meaningful*
17 *number of entities would fall under that defini-*
18 *tion; and*

19 (2) *submit to Congress a report that includes—*

20 (A) *the results of the applicable study con-*
21 *ducted under paragraph (1); and*

22 (B) *specific and detailed recommendations*
23 *on the ways in which the Commission could*
24 *amend the definition of the term “small entity”*
25 *to—*

1 (i) be consistent with the results de-
2 scribed in subparagraph (A); and

3 (ii) expand the number of entities cov-
4 ered by such definition.

5 (c) *RULEMAKING.*—Concurrently with, or after the
6 completion of, each study required under subsection (b), the
7 Commission shall, subject to public notice and comment, re-
8 vise the rules of the Commission consistent with the results
9 of such study.

10 (d) *INFLATION ADJUSTMENTS.*—After the Commission
11 issued the final rule revisions required under subsection (c),
12 and every 5 years thereafter, the Commission shall adjust
13 any dollar figures under the definition of small entity estab-
14 lished by the Commission to reflect the change in the Con-
15 sumer Price Index for All Urban Consumers published by
16 the Bureau of Labor Statistics of the Department of Labor.
