# A BILL

To establish a task force on street racing.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “They’re Fast, We’re  
5       Furious Act of 2025”.

**6 SEC. 2. STREET RACING PREVENTION AND INTERVENTION**

**7           TASK FORCE.**

8       (a) ESTABLISHMENT.—Not later than 90 days after  
9       the date of the enactment of this Act, the Director of the  
10      Federal Bureau of Investigation shall establish a task  
11      force to be known as the “Street Racing Prevention and

1 Intervention Task Force” (hereinafter referred to as the  
2 “Task Force”).

3 (b) COMPOSITION.—The Task Force shall consist of  
4 the following members:

5 (1) 2 members, appointed by the Attorney Gen-  
6 eral, who are employees of the Criminal Division of  
7 the Department of Justice.

8 (2) 2 members, appointed by the Secretary of  
9 Transportation, who are employees of the National  
10 Highway Traffic Safety Administration.

11 (3) 2 members, appointed by the Attorney Gen-  
12 eral, who are representatives of State or local law  
13 enforcement agencies.

14 (4) 3 members, appointed by the Director of  
15 the Federal Bureau of Investigation, who are em-  
16 ployees of the Federal Bureau of Investigation.

17 (c) DUTIES.—The duties of the Task Force shall in-  
18 clude—

19 (1) studying the prevalence and impacts of  
20 street racing, vehicle sideshows, and street take-  
21 overs;

22 (2) developing best practices for a national ap-  
23 proach to combat organized street racing;

24 (3) developing best practices for State and local  
25 law enforcement agencies to deal with street racing;

1                             (4) developing educational materials on how to  
2 prevent and respond to street racing;

3                             (5) distributing the materials described under  
4 paragraph (4); and

5                             (6) coordinating the response of local, State,  
6 and Federal law enforcement agencies to street rac-  
7 ing.

8                             (d) REPORT.—Not later than one year after the date  
9 of the enactment of the Act, the Task Force shall submit  
10 to the Committee on the Judiciary of the House of Rep-  
11 resentatives and the Committee on the Judiciary of the  
12 Senate a report on the progress the Task Force has made  
13 in completing the duties assigned under subsection (c).

14                             (e) DEFINITIONS.—In this section:

15                                 (1) STREET RACING.—The term “street racing”  
16 means a race of two or more vehicles on a public  
17 road in an area that is not designated for an official  
18 race.

19                                 (2) VEHICLE SIDESHOW.—The term “vehicle  
20 sideshow” means an event of two or more individ-  
21 uals blocking or impeding traffic on a highway for  
22 the purpose of performing motor vehicle stunts,  
23 motor vehicle speed contests, motor vehicle exhibi-  
24 tions of speed, or reckless driving for spectators.
