Mr. ZINKE (for himself and Mr. PANETTA) introduced the following bill; which was referred to the Committee on Foreign Affairs

A BILL

To amend the Arms Export Control Act to streamline Foreign Military Sales under that Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Streamlining Foreign
5 Military Sales Act of 2025”.

6 **SEC. 2. AMENDMENTS TO ARMS EXPORT CONTROL ACT.**

7 The Arms Export Control Act (22 U.S.C. 2751 et
8 seq.) is amended—

1 (1) in section 36(a)(10), by striking
2 “\$250,000” each place it appears and inserting
3 “\$500,000”;

4 (2) in section 25(a)(1), by striking
5 “\$7,000,000” and inserting “\$30,000,000”;

6 (3) in section 25(a)(1), by striking
7 “25,000,000” and inserting “105,000,000”;

8 (4) in sections 3(d)(1), 3(d)(3)(A), 36(b)(1),
9 35(b)(5)(C), 36(c)(1), and 63(a)(1), by striking
10 “\$14,000,000” each place it appears and inserting
11 “\$30,000,000”;

12 (5) in sections 3(d)(5), 25(a)(1), 36(b)(6)(A),
13 36(c)(5)(A) and 63(a)(2), by striking
14 “\$25,000,000” each place it appears and inserting
15 “\$55,000,000”;

16 (6) in sections 3(d)(1), 3(d)(3)(A), 36(b)(1),
17 36(b)(5)(C), 36(c)(1), 47(6), 63(a)(1), and 71(d), by
18 striking “\$50,000,000” each place it appears and in-
19 serting “\$105,000,000”;

20 (7) in sections 3(d)(5), 36(b)(6)(B),
21 36(c)(5)(B), and 63(a)(2), by striking
22 “\$100,000,000” each place it appears and inserting
23 “\$205,000,000”;

1 (8) in sections 36(b)(1), 36(b)(5)(C), and
2 47(6), by striking “\$200,000,000” each place it ap-
3 pears and inserting “\$410,000,000”; and
4 (9) in section 36(b)(6)(C), by striking
5 “\$300,000,000” and inserting “\$615,000,000”.
