## AN ACT

To amend the Homeland Security Act of 2002 to enhance outreach for the Urban Area Security Initiative and the State Homeland Security Grant Program of the Department of Homeland Security, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Enhancing Stakeholder
- 3 Support and Outreach for Preparedness Grants Act".
- 4 SEC. 2. DHS GRANT OUTREACH.
- 5 (a) Urban Area Security Initiative.—Section
- 6 2003 of the Homeland Security Act of 2002 (6 U.S.C.
- 7 604) is amended by adding at the end the following new
- 8 subsection:
- 9 "(f) Outreach and Technical Assistance.—The
- 10 Administrator shall, on an ongoing basis, provide stake-
- 11 holder outreach, engagement, education, technical assist-
- 12 ance, and support, prior to, during, and after the awarding
- 13 of grants under this section, including relating to the fol-
- 14 lowing:
- "(1) Conducting annual surveys to collect feed-
- back from State, local, Tribal, and territorial stake-
- holders on the awarding of such grants and the ef-
- fectiveness of the Administrator's outreach efforts.

- 7 ing, and after the awarding of grants under the Urban
- 8 Area Security Initiative and State Homeland Security
- 9 Grant Program, in accordance with subsection (f) of sec-
- 10 tion 2003 and subsection (g) of section 2004, respectively,
- 11 of the Homeland Security Act of 2002, as added by sub-
- 12 sections (a) and (b), respectively.
- 13 (d) Report.—Not later than three years after the
- 14 date of the enactment of this Act, the Administrator of
- 15 the Federal Emergency Management Agency shall submit
- 16 to the Committee on Homeland Security of the House of
- 17 Representatives and the Committee on Homeland Security
- 18 and Governmental Affairs of the Senate a report regard-
- 19 ing the actions taken pursuant to subsection (f) of section
- 20 2003 and subsection (g) of section 2004 of the Homeland
- 21 Security Act of 2002, as added by subsections (a) and (b),
- 22 respectively, including with respect to the surveys and

- 1 summaries required under paragraphs (1) and (2) of each
- 2 of such subsections (f) and (g).
