A BILL

To amend the Federal Lands Recreation Enhancement Act to clarify entrance privileges for vehicles with respect to the America the Beautiful interagency pass.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “America the Beautiful*
 5 *Motorcycle Fairness Act”.*

6 **SEC. 2. ADMINISTRATIVE GUIDELINES.**

7 *Section 805(a)(7) of the Federal Lands Recreation En-*
 8 *hancement Act (16 U.S.C. 6804(a)(7)) is amended—*

9 *(1) by striking “The Secretaries shall issue*
 10 *guidelines” and inserting the following:*

11 *“(A) IN GENERAL.—The Secretaries shall*
 12 *issue guidelines”; and*

13 *(2) by adding at the end the following:*

14 *“(B) VEHICLES.—For purposes of this*
 15 *paragraph, where a National Parks and Federal*
 16 *Recreational Lands Pass is used for access to*
 17 *Federal recreational lands and waters on a per-*
 18 *vehicle fee basis, such Pass shall cover the en-*
 19 *trance fee and standard amenity recreation fee—*

20 *“(i) for the passholder and any pas-*
 21 *sengers accompanying the passholder in a*
 22 *single private, noncommercial vehicle; or*

23 *“(ii) if the passholder is entering by*
 24 *motorcyle—*

1 “(I) the passholder and any pas-
2 sengers on the motorcyle; and
3 “(II) one additional motorcycle,
4 including passengers, accompanying
5 the passholder.”.
