## A BILL

To amend title 23, United States Code, to establish an agricultural and rural road improvement program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Agricultural and Rural  
5 Road Improvement Program Act”.

1   **SEC. 2. AGRICULTURAL AND RURAL ROAD IMPROVEMENT**

2                   **PROGRAM.**

3       (a) IN GENERAL.—Chapter 1 of title 23, United  
4 States Code, is amended by adding at the end of the fol-  
5 lowing:

6   **“§ 180. Agricultural and rural road improvement pro-**

7                   **gram**

8       “(a) ESTABLISHMENT.—The Secretary shall estab-  
9 lish and implement an agricultural and rural road im-  
10 provement program to—

11       “(1) improve first- and last-mile access to  
12 farms and to facilities producing, supplying, storing,  
13 and transporting agricultural inputs and products;

14       “(2) reduce the number of weight-limited  
15 bridges and capacity-limited local roads and rural  
16 minor collectors in rural communities; and

17       “(3) improve the safety, resiliency, and effi-  
18 ciency of the local roads and rural minor collectors  
19 that are essential to a strong American agricultural  
20 sector and a vibrant rural economy.

21       “(b) ELIGIBLE PROJECTS.—Funds apportioned to a  
22 State under subsection 104(b)(9) to carry out this section  
23 may only be obligated for a project that is on a road func-  
24 tionally classified as a local road or rural minor collector  
25 road and that is—

1           “(1) a project to replace or rehabilitate one or  
2       more bridges in order to eliminate a posted weight  
3       limitation;

4           “(2) a project on a highway or bridge that pro-  
5       vides or increases first- and last-mile access to a  
6       farm, facility producing, supplying, storing, and  
7       transporting agricultural inputs and products, agri-  
8       cultural facility, or other facility that supports the  
9       economy of a rural area;

10          “(3) a project eligible under section  
11       167(h)(5)(C); and

12          “(4) a project to improve highway safety, in-  
13       cluding a project to improve a high risk rural road  
14       (as defined in section 148).

15          “(c) FEDERAL COST SHARE.—The Federal share of  
16       the cost of a project carried out under this section may  
17       not exceed 90 percent.”.

18          (b) CLERICAL AMENDMENT.—The analysis for chap-  
19       ter 1 of title 23, United States Code, is amended by add-  
20       ing at the end the following:

“180. Agricultural and rural road improvement program.”.

21 **SEC. 3. CONFORMING AMENDMENTS.**

22          (a) APPORTIONMENT.—Section 104(b) of title 23,  
23       United States Code, is amended—

24           (1) by inserting “the agricultural and rural  
25       road improvement program,” after “section 175,”;

1                   (2) in paragraph (7), by striking  
2       “2.56266964565637” and inserting “2.02664265”;  
3       and

4                   (3) by adding at the end the following:

5                   “(9) AGRICULTURAL AND RURAL ROAD IM-  
6       PROVEMENT PROGRAM.—For the agricultural and  
7       rural road improvement program under section 180,  
8       0.536027 percent of the amount remaining after dis-  
9       tributing amounts under paragraphs (4), (5), and  
10      (6).”.

11               (b) CARBON REDUCTION PROGRAM.—Section  
12 175(e)(1)(A) of title 23, United States Code, is amend-  
13 ed—

14               (1) in clause (i) by adding “and” at the end;  
15               (2) in clause (ii) by adding “and” at the end;  
16       and  
17               (3) by striking clauses (iii) and (iv).
