A BILL

To name the Department of Veterans Affairs community-based outpatient clinic in Bloomington, Illinois, as the “Andrew Jackson Smith Medal of Honor Department of Veterans Affairs Clinic”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress makes the following findings:

5 (1) Color Sergeant Andrew Jackson Smith of
6 the 55th Massachusetts Infantry Regiment, formerly

1 of the 41st Illinois Infantry Regiment, was post-
2 humously awarded the Medal of Honor for his heroic
3 actions in the Civil War.

4 (2) His Medal of Honor citation reads “Cor-
5 poral Andrew Jackson Smith, of Clinton, Illinois, a
6 member of the 55th Massachusetts Voluntary Infan-
7 try, distinguished himself on 30 November 1864 by
8 saving his regimental colors, after the color bearer
9 was killed during a bloody charge at the Battle of
10 Honey Hill, South Carolina. In the late afternoon,
11 as the 55th Regiment pursued enemy skirmishers
12 and conducted a running fight, they ran into a
13 swampy area backed by a rise where the Confederate
14 Army awaited. The surrounding woods and thick un-
15 derbrush impeded infantry movement and artillery
16 support. The 55th and 54th regiments formed col-
17 umns to advance to the enemy position in a flanking
18 movement. As the Confederates repelled other units,
19 the 55th and 54th regiments continued to move into
20 flanking positions. Forced into a narrow gorge cross-
21 ing a swamp in the face of the enemy positions, the
22 55th’s Color-Sergeant was killed by an exploding
23 shell, and Corporal Smith took the Regimental Col-
24 ors from his hand and carried them through heavy
25 grape and canister fire. Although half of the officers

1 and a third of the enlisted men engaged in the fight
2 were killed or wounded, Corporal Smith continued to
3 expose himself to the enemy fire by carrying the col-
4 ors throughout the battle. Through his actions, the
5 Regimental Colors of the 55th Infantry Regiment
6 were not lost to the enemy. Corporal Andrew Jack-
7 son Smith's extraordinary valor in the face of deadly
8 enemy fire is in keeping with the highest traditions
9 of military service and reflect great credit upon him,
10 the 55th Regiment, and the United States Army.".

11 **SEC. 2. NAME OF DEPARTMENT OF VETERANS AFFAIRS**
12 **COMMUNITY-BASED OUTPATIENT CLINIC,**
13 **BLOOMINGTON, ILLINOIS.**

14 The Department of Veterans Affairs community-
15 based outpatient clinic located at 207 Hamilton Road,
16 Bloomington, Illinois, shall after the date of enactment of
17 this Act be known and designated as the "Andrew Jackson
18 Smith Medal of Honor Department of Veterans Affairs
19 Clinic". Any reference to such clinic in any law, regula-
20 tion, map, document, record, or other paper of the United
21 States shall be considered to be a reference to the Andrew
22 Jackson Smith Medal of Honor Department of Veterans
23 Affairs Clinic.
