## A BILL

To amend chapter 6 of title 5, United States Code, to provide additional requirements for the periodic review of rules, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Regulatory Evidence-  
5 based Standards for Thorough Accountability and Reas-  
6 suring Tests—Securing Updated and Necessary Statutory  
7 Evaluations Timely Act of 2025” or the “RESTART  
8 SUNSET Act of 2025”.

## 1 SEC. 2. ADDITIONAL REQUIREMENTS FOR PERIODIC RE-

2           **VIEW OF RULES.**3           (a) PERIODIC REVIEW OF RULES.—Section 610 of  
4 title 5, United States Code, is amended—

5           (1) in subsection (a)—

6               (A) in the first sentence, by striking  
7               “Within one hundred and eighty days after the  
8               effective date of this chapter, each agency shall  
9               publish in the Federal Register a plan for the  
10              periodic review of the rules” and inserting  
11              “Each agency shall periodically review the  
12              rules”;

13               (B) by striking the second sentence;

14               (C) by striking “The plan shall provide for  
15              the review of all such agency rules existing on  
16              the effective date of this chapter within ten  
17              years of that date and for the review of such  
18              rules adopted after the effective date of this  
19              chapter within ten years of the publication of  
20              such rules as the final rule.” and inserting  
21              “Each agency shall review all such agency rules  
22              existing on the date of enactment of the RE-  
23              START SUNSET Act of 2025 within ten years  
24              of that date and review such rules adopted after  
25              the date of enactment of the RESTART SUN-

1           SET Act of 2025 within 10 years of the publi-  
2           cation of such rules as the final rule.”; and

3           (D) in subsection (c), by adding at the end  
4           the following: “Each year, each agency shall  
5           publish in the Federal Register a list of the  
6           rules which do not have a significant economic  
7           impact on a substantial number of small enti-  
8           ties, and the basis for such conclusion.”.

9           (b) JUDICIAL REVIEW.—Section 611(a) of title 5,  
10       United States Code, is amended—

11           (1) in paragraph (4), by inserting “except as  
12           provided in paragraph (5)” before “the court shall  
13           order”;

14           (2) by redesignating paragraph (5) as para-  
15           graph (6); and

16           (3) by inserting after paragraph (4) the fol-  
17           lowing:

18           “(5) Notwithstanding any other provision of  
19           this section, if the court finds that the agency failed  
20           to comply with section 610 with respect to a rule,  
21           the court shall enter an order prohibiting enforce-  
22           ment of such rule.”.
