AN ACT

To extend military land withdrawals in Alaska, New Mexico, and California for a period of 25 years and to make technical corrections to descriptions for certain military land withdrawals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Public Lands Military
3 Readiness Act of 2025”.

4 **SEC. 2. EXTENSION OF CERTAIN MILITARY LAND WITH-**
5 **DRAWALS AND CORRECTION OF CERTAIN**
6 **LAND DESCRIPTIONS.**

7 (a) EXTENSION OF WITHDRAWAL AND RESERVATION
8 FOR MILITARY USE OF CERTAIN LANDS.—

9 (1) YUKON TRAINING AREA, DONNELLY TRAIN-
10 ING AREA EAST, AND DONNELLY TRAINING AREA
11 WEST, ALASKA, AND MCGREGOR RANGE, FORT BLISS,
12 NEW MEXICO.—Section 3015(a) of the Military
13 Lands Withdrawal Act of 1999 (title XXX of Public
14 Law 106–65; 113 Stat. 892) is amended by striking
15 “25 years after November 6, 2001” and inserting
16 “on November 6, 2051”.

17 (2) FORT IRWIN MILITARY LANDS.—Section
18 2910(a) of the Fort Irwin Military Land Withdrawal
19 Act of 2001 (title XXIX of Public Law 107–107;
20 115 Stat. 1339) is amended by striking “25 years
21 after the date of the enactment of this Act” and in-
22 serting “on December 31, 2051”.

23 (b) CORRECTION OF LAND DESCRIPTIONS.—

24 (1) MCGREGOR RANGE MILITARY LANDS.—Sec-
25 tion 3011(d)(2) of the Military Lands Withdrawal
26 Act of 1999 (title XXX of Public Law 106–65; 113

1 Stat. 892) is amended by striking “608,385 acres of
2 land” and inserting “approximately 605,401 acres of
3 land”.

4 (2) FORT IRWIN MILITARY LANDS.—Section
5 2902(c) of the Fort Irwin Military Land Withdrawal
6 Act of 2001 (title XXIX of Public Law 107–107;
7 115 Stat. 1336) is amended—

8 (A) by striking “110,000 acres” and in-
9 serting “117,710 acres”; and

10 (B) by striking “as ‘Proposed Withdrawal
11 Land’ on the map entitled ‘National Training
12 Center—Proposed Withdrawal of Public Lands
13 for Training Purposes’, dated September 21,
14 2000” and inserting “on the map entitled ‘Fort
15 Irwin Withdrawal’ dated February 28, 2025”.
