To repeal the Second Chance Amendment Act of 2022 and
the Incarceration Reduction Amendment Act of 2016.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL OF SECOND CHANCE AMENDMENT ACT**
 4 **OF 2022 AND INCARCERATION REDUCTION**
 5 **AMENDMENT ACT OF 2016.**

6 (a) *SECOND CHANCE AMENDMENT ACT OF 2022.—The*
 7 *Second Chance Amendment Act of 2022 (D.C. Law 24–284)*
 8 *is hereby repealed, and any provision of law amended or*
 9 *repealed by such Act is restored or revived as if such Act*
 10 *had not been enacted into law.*

11 (b) *INCARCERATION REDUCTION ACT OF 2016.— The*
 12 *Incarceration Reduction Amendment Act of 2016 (title III*
 13 *of the Comprehensive Youth Justice Amendment Act of*
 14 *2016; D.C. Law 21–238) is hereby repealed, and any provi-*
 15 *sion of law amended or repealed by such Act is restored*
 16 *or revived as if such Act had not been enacted into law.*

17 **SEC. 2. TERMINATION OF AUTOMATED TRAFFIC ENFORCE-**
 18 **MENT SYSTEM.**

19 *Title IX of the Fiscal Year 1997 Budget Support Act*
 20 *of 1996 (sec. 50–2209.01 et seq., D.C. Official Code) is here-*
 21 *by repealed.*

1 **SEC. 3. ELIMINATING RESTRICTIONS ON RIGHT TURNS AT**
2 **RED TRAFFIC SIGNALS.**

3 *Section 9e of the District of Columbia Traffic Act,*
4 *1925, approved March 3, 1925 (sec. 50– 2201.04e, D.C. Of-*
5 *ficial Code) is repealed.*

6 **SEC. 4. EFFECTIVE DATE.**

7 *This Act, and the amendments made by this Act, shall*
8 *apply with respect to criminal conduct that occurred after*
9 *the date of the enactment of this Act.*
