A BILL

To amend title 18, United States Code, to prohibit surrogacy arrangements for sex offenders, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Surrogacy for Sex
5 Offenders Act”.

6 **SEC. 2. PROHIBITION ON SURROGACY ARRANGEMENTS IN-**
7 **VOLVING SEX OFFENDERS.**

8 (a) IN GENERAL.—Chapter 109B of title 18, United
9 States Code, is amended by adding at the end the fol-
10 lowing:

1 **“§ 2250A. Surrogacy arrangements involving sex of-**
2 **fenders**

3 “(a) A person who is a sex offender and, while re-
4 quired to register under the Sex Offender Registration and
5 Notification Act, uses an instrumentality of interstate or
6 foreign commerce to enter into a surrogacy arrangement,
7 with respect to a child carried in pregnancy by another
8 person in consequence of carrying out the arrangement,
9 with the intent to exercise the parental rights with respect
10 to the child, shall be fined under this title or imprisoned
11 not more than 18 years, or both.

12 “(b) A person who uses an instrumentality of inter-
13 state or foreign commerce to enter into a surrogacy ar-
14 rangement, with respect to a child carried in pregnancy
15 by another person in consequence of carrying out the ar-
16 rangement, with the intent to exercise the parental rights
17 with respect to the child, and commits a sex offense, any
18 part or element of which is committed in the period that
19 begins with the use of the instrumentality and ends with
20 the birth of the child, shall be fined under this title or
21 imprisoned not more than 18 years, or both.

22 “(c) In this section:

23 “(1) The terms ‘sex offender’ and ‘sex offense’
24 have the meanings given the terms in section 111 of
25 the Sex Offender Registration and Notification Act
26 (34 U.S.C. 20911).

1 “(2) The term ‘surrogacy arrangement’ means
2 any arrangement in which a person agrees to carry
3 a child in pregnancy, which is not initiated at the
4 time that the arrangement is made, with the expect-
5 tation that—

6 “(A) the person shall not exercise any pa-
7 rental rights with respect to the child; and

8 “(B) another person who agrees to the ar-
9 rangement shall exercise the parental rights
10 with respect to the child.”.

11 (b) CONFORMING AMENDMENT.—The table of sec-
12 tions for such chapter is amended by adding at the end
13 the following:

“2250A. Surrogacy arrangements involving sex offenders.”.
