Mr. HORSFORD (for himself, Mrs. KIGGANS of Virginia, Mr. BACON, Ms. HOULAHAN, Ms. GOODLANDER, Mr. BISHOP, Ms. MCBRIDE, and Mr. MOYLAN) introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To require the Secretary of Defense to establish a digital system for the submission of complaints relating to access issues at military medical treatment facilities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Care, Access,
5 Reporting, and Evaluation Act” or the “Military CARE
6 Act”.

1 **SEC. 2. DIGITAL SYSTEM FOR ACCESS ASSISTANCE AT MILI-**
2 **TARY MEDICAL TREATMENT FACILITIES.**

3 (a) DIGITAL SYSTEM FOR ACCESS ASSISTANCE.—

4 Not later than 18 months after the date of the enactment
5 of this Act, the Secretary of Defense shall establish a dig-
6 ital system under which—

7 (1) a covered beneficiary who receives health
8 care at a military medical treatment facility may
9 electronically—

10 (A) file a complaint relating to access to
11 care at such military medical treatment facility;
12 and

13 (B) view the status of such complaint at
14 any time, including the status of any interim or
15 final action taken to address the complaint;

16 (2) any complaint filed under paragraph (1)(A)
17 shall be promptly transmitted to an appropriate pa-
18 tient advocate of the Department of Defense; and

19 (3) complaints filed under paragraph (1)(A)
20 with respect to a military medical treatment facility
21 may be automatically aggregated and submitted to
22 the Director of the Defense Health Agency on a
23 quarterly basis.

24 (b) REPORT ON COMPLAINTS FILED UNDER DIGITAL
25 SYSTEM.—

1 (1) SUBMISSION.—Not later than March 1 of
2 each year following the establishment of the system
3 under subsection (a), the Secretary of Defense shall
4 submit to the Committees on Armed Services of the
5 House of Representatives and the Senate a report on
6 the total number of complaints filed under such sys-
7 tem.

8 (2) ELEMENTS.—Each report under paragraph
9 (1) shall include, for each military medical treatment
10 facility with respect to which a complaint was filed
11 under the system under subsection (a), the following:

12 (A) An identification of the most common
13 access to care complaints filed by covered bene-
14 ficiaries with respect to such facility.

15 (B) A comparison of the number of com-
16 plaints so filed regarding access to specialty
17 care versus access to primary care.

18 (C) A comparison of the number of com-
19 plaints so filed regarding access to pediatric
20 versus non-pediatric care.

21 (D) A comparison of the number of com-
22 plaints so filed regarding administrative hurdles
23 to access versus other access issues.

1 (E) A summary of steps taken at such fa-
2 cility to reduce access to care complaints by
3 covered beneficiaries.

4 (c) COVERED BENEFICIARY DEFINED.—In this sec-
5 tion, the term “covered beneficiary” means an individual
6 enrolled in a health care plan under the TRICARE pro-
7 gram and eligible to receive care at a military medical
8 treatment facility.
