RESOLUTION

Authorizing and directing certain authorizing committees to review laws within their jurisdiction and submit to the Committee on Oversight and Government Reform changes in such laws necessary to eliminate excessive Executive Branch discretion in the application of those laws.

1 *Resolved,*

2 **SECTION 1. SHORT TITLE.**

3 This resolution may be cited as the “Fair Represen-
4 tation Amendment”.

1 **SEC. 2. AUTHORIZING COMMITTEE ACTIONS.**

2 (a) IN GENERAL.—Within 6 months after the date
3 of adoption of this resolution, the committees listed in sub-
4 section (b) shall review laws within their jurisdiction and
5 submit to the Committee on Oversight and Government
6 Reform changes in those laws sufficient to eliminate exces-
7 sive Executive Branch discretion in the application of
8 those laws.

9 (b) COMMITTEES SUBJECT TO SUBSECTION (a).—
10 The following committees shall comply with subsection (a):

11 (1) Committee on Agriculture.

12 (2) Committee on Armed Services.

13 (3) Committee on the Budget.

14 (4) Committee on Energy and Commerce.

15 (5) Committee on Education and the Work-
16 force.

17 (6) Committee on Financial Services.

18 (7) Committee on Foreign Affairs.

19 (8) Committee on the Judiciary.

20 (9) Committee on Natural Resources.

21 (10) Committee on Oversight and Government
22 Reform.

23 (11) Committee on Science, Space, and Tech-
24 nology.

25 (12) Committee on Small Business.

1 (13) Committee on Transportation and Infra-
2 structure.

3 (14) Committee on Veterans Affairs.

4 (15) Committee on Ways and Means.

5 (16) Permanent Select Committee on Intel-
6 ligence.

7 **SEC. 3. LEGISLATIVE PROCEDURE.**

8 Upon receiving all the recommendations made pursu-
9 ant to section 1, the Committee on Oversight and Govern-
10 ment Reform shall expeditiously report legislation carrying
11 out all such recommendations without any substantive re-
12 vision. The short title of this legislation shall be the Article
13 One Restoration Act.
