Providing for consideration of the bill (H.R. 3944) making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2026, and for other purposes; providing for consideration of the bill (H.R. 275) to require the Secretary of Homeland Security to publish on a monthly basis the number of special interest aliens encountered attempting to unlawfully enter the United States, and for other purposes; providing for consideration of the bill (H.R. 875) to amend the Immigration and Nationality Act to provide that aliens who have been convicted of or who have committed an offense for driving while intoxicated or impaired are inadmissible and deportable; and providing for consideration of the resolution (H. Res. 516) condemning the violent June 2025 riots in Los Angeles, California.

Mr. AUSTIN SCOTT of Georgia, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3944) making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2026, and for other purposes; providing for consideration of the bill (H.R. 275) to

require the Secretary of Homeland Security to publish on a monthly basis the number of special interest aliens encountered attempting to unlawfully enter the United States, and for other purposes; providing for consideration of the bill (H.R. 875) to amend the Immigration and Nationality Act to provide that aliens who have been convicted of or who have committed an offense for driving while intoxicated or impaired are inadmissible and deportable; and providing for consideration of the resolution (H. Res. 516) condemning the violent June 2025 riots in Los Angeles, California.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3944) making appropriations for
6 military construction, the Department of Veterans Affairs,
7 and related agencies for the fiscal year ending September
8 30, 2026, and for other purposes. The first reading of the
9 bill shall be dispensed with. All points of order against
10 consideration of the bill are waived. General debate shall
11 be confined to the bill and shall not exceed one hour equal-
12 ly divided and controlled by the chair and ranking minor-
13 ity member of the Committee on Appropriations or their
14 respective designees. After general debate the bill shall be
15 considered for amendment under the five-minute rule. An
16 amendment in the nature of a substitute consisting of the
17 text of Rules Committee Print 119–5 shall be considered

1 as adopted in the House and in the Committee of the
2 Whole. The bill, as amended, shall be considered as the
3 original bill for the purpose of further amendment under
4 the five-minute rule and shall be considered as read.
5 Points of order against provisions in the bill, as amended,
6 for failure to comply with clause 2 of rule XXI are waived.

7 SEC. 2. (a) No further amendment to H.R. 3944, as
8 amended, shall be in order except those printed in the re-
9 port of the Committee on Rules accompanying this resolu-
10 tion, amendments en bloc described in section 3 of this
11 resolution, and pro forma amendments described in sec-
12 tion 4 of this resolution.

13 (b) Each further amendment printed in the report of
14 the Committee on Rules shall be considered only in the
15 order printed in the report, may be offered only by a Mem-
16 ber designated in the report, shall be considered as read,
17 shall be debatable for the time specified in the report
18 equally divided and controlled by the proponent and an
19 opponent, shall not be subject to amendment except as
20 provided by section 4 of this resolution, and shall not be
21 subject to a demand for division of the question in the
22 House or in the Committee of the Whole.

23 (c) All points of order against further amendments
24 printed in the report of the Committee on Rules or against

1 amendments en bloc described in section 3 of this resolu-
2 tion are waived.

3 SEC. 3. It shall be in order at any time for the chair
4 of the Committee on Appropriations or his designee to
5 offer amendments en bloc consisting of further amend-
6 ments printed in the report of the Committee on Rules
7 accompanying this resolution not earlier disposed of.

8 Amendments en bloc offered pursuant to this section shall
9 be considered as read, shall be debatable for 20 minutes
10 equally divided and controlled by the chair and ranking
11 minority member of the Committee on Appropriations or
12 their respective designees, shall not be subject to amend-
13 ment except as provided by section 4 of this resolution,
14 and shall not be subject to a demand for division of the
15 question in the House or in the Committee of the Whole.

16 SEC. 4. During consideration of H.R. 3944 for
17 amendment, the chair and ranking minority member of
18 the Committee on Appropriations or their respective des-
19 ignees may offer up to 10 pro forma amendments each
20 at any point for the purpose of debate.

21 SEC. 5. At the conclusion of consideration of H.R.
22 3944 for amendment the Committee shall rise and report
23 the bill, as amended, to the House with such further
24 amendments as may have been adopted. The previous
25 question shall be considered as ordered on the bill, as

1 amended, and on any further amendment thereto, to final
2 passage without intervening motion except one motion to
3 recommit.

4 SEC. 6. Upon adoption of this resolution it shall be
5 in order to consider in the House the bill (H.R. 275) to
6 require the Secretary of Homeland Security to publish on
7 a monthly basis the number of special interest aliens en-
8 countered attempting to unlawfully enter the United
9 States, and for other purposes. All points of order against
10 consideration of the bill are waived. The amendment in
11 the nature of a substitute recommended by the Committee
12 on Homeland Security now printed in the bill shall be con-
13 sidered as adopted. The bill, as amended, shall be consid-
14 ered as read. All points of order against provisions in the
15 bill, as amended, are waived. The previous question shall
16 be considered as ordered on the bill, as amended, and on
17 any further amendment thereto, to final passage without
18 intervening motion except: (1) one hour of debate equally
19 divided and controlled by the chair and ranking minority
20 member of the Committee on Homeland Security or their
21 respective designees; and (2) one motion to recommit.

22 SEC. 7. Upon adoption of this resolution it shall be
23 in order to consider in the House the bill (H.R. 875) to
24 amend the Immigration and Nationality Act to provide
25 that aliens who have been convicted of or who have com-

1 mitted an offense for driving while intoxicated or impaired
2 are inadmissible and deportable. All points of order
3 against consideration of the bill are waived. The amend-
4 ment in the nature of a substitute recommended by the
5 Committee on the Judiciary now printed in the bill shall
6 be considered as adopted. The bill, as amended, shall be
7 considered as read. All points of order against provisions
8 in the bill, as amended, are waived. The previous question
9 shall be considered as ordered on the bill, as amended,
10 and on any further amendment thereto, to final passage
11 without intervening motion except: (1) one hour of debate
12 equally divided and controlled by the chair and ranking
13 minority member of the Committee on the Judiciary or
14 their respective designees; and (2) one motion to recom-
15 mit.

16 SEC. 8. Upon adoption of this resolution it shall be
17 in order without intervention of any point of order to con-
18 sider in the House the resolution (H. Res. 516) con-
19 demning the violent June 2025 riots in Los Angeles, Cali-
20 fornia. The resolution shall be considered as read. The
21 previous question shall be considered as ordered on the
22 resolution and preamble to adoption without intervening
23 motion or demand for division of the question except one
24 hour of debate equally divided and controlled by the chair
