## RESOLUTION

Commemorating the 65th anniversary of the Marshall Space Flight Center and recognizing its continued leadership in the development of the Space Launch System and human space exploration.

Whereas the Marshall Space Flight Center (MSFC), located in Huntsville, Alabama, was officially established on July 1, 1960, as one of the National Aeronautics and Space Administration's (NASA) premier centers for spaceflight research and development;

Whereas MSFC played a pivotal role in the historic Apollo program, designing and developing the Saturn V rocket that carried astronauts to the Moon and marked a defin-

ing achievement in American scientific and engineering excellence;

Whereas MSFC has consistently led innovation and mission support for critical NASA programs, including Skylab, America's first space station, the Hubble Space Telescope, Chandra X-ray Observatory, and numerous other scientific payloads that have revolutionized understanding of the universe;

Whereas MSFC has provided engineering leadership, payload integration, and science operations in support of the International Space Station (ISS), helping maintain a continuous human presence in space since the year 2000;

Whereas MSFC continues to serve as the lead center for the development and integration of the Space Launch System (SLS), NASA's most powerful launch vehicle since Saturn V, and a cornerstone of the Artemis program;

Whereas the SLS represents the Nation's commitment to returning humans to the Moon, preparing for future crewed missions to Mars, and expanding deep space exploration for generations to come;

Whereas MSFC's leadership in the SLS program exemplifies the Center's unmatched technical expertise in large-scale propulsion systems, systems integration, and complex spaceflight engineering;

Whereas the Center continues to serve as an anchor for the aerospace industry and STEM education in the Tennessee Valley region and beyond, providing high-tech jobs, economic opportunity, and outreach to schools and universities; and

Whereas the Marshall Space Flight Center is home to a dedicated workforce committed to excellence, safety, integrity, and teamwork; Now, therefore, be it

11                 velopment and integration of the Space Launch Sys-  
12                 tem (SLS) as the leading technology for deep space  
13                 exploration;

14                 (4) reaffirms the House of Representatives  
15                 strong support for the ongoing mission of the Mar-  
16                 shall Space Flight Center and the broader goals of  
17                 NASA's Artemis program and beyond; and

19                 tion of the engineers, scientists, technicians, and
