## RESOLUTION

Of inquiry requesting the President to transmit certain information to the House of Representatives referring to United States Government agencies sharing certain communications with the public and Federal employees.

1       *Resolved*, That the President is requested to transmit,  
2 to the extent that such documents are in the possession  
3 of the President, to the House of Representatives, not  
4 later than 14 days after the adoption of this resolution,  
5 in complete and unredacted form, a copy of the following:

1           (1) Any and all documents and communica-  
2           tions, including notes from meetings, audio records,  
3           telephone and electronic mail records, text and other  
4           digital messages, related to a directive from the Of-  
5           fice of Management and Budget to Federal agencies  
6           directing them to include certain language in com-  
7           munications to employees regarding a potential lapse  
8           in appropriations.

9           (2) Any and all documents and communica-  
10          tions, including notes from meetings, audio records,  
11          telephone and electronic mail records, text and other  
12          digital messages, related to the Department of  
13          Housing and Urban Development posting a message  
14          on their website reading “The Radical Left in Con-  
15          gress shut down the government. HUD will use  
16          available resources to help Americans in need.”.

17          (3) Any and all documents and communica-  
18          tions, including notes from meetings, audio records,  
19          telephone and electronic mail records, text and other  
20          digital messages, related to the decision of the De-  
21          partment of Education to modify the out-of-office  
22          email messages of furloughed employees to read as  
23          follows: “Thank you for contacting me. On Sep-  
24          tember 10, 2025, the House of Representatives  
25          passed H.R. 5371, a clean continuing resolution.

1       Unfortunately, Democrat Senators are blocking pas-  
2       sage of H.R. 5371 in the Senate which has led to  
3       a lapse in appropriations. Due to the lapse of appro-  
4       priations, I am currently in furlough status. I will  
5       respond to emails once government functions re-  
6       sume.”.

7               (4) Any and all documents or communications  
8       between the Office of the President, the Office of the  
9       Vice President, the Office of Personnel Management,  
10       the Office of Management and Budget, and the Of-  
11       fice of Special Counsel on whether any communica-  
12       tions issued from official Federal Government  
13       sources regarding the Federal Government lapse in  
14       appropriations occurring in October 2025 con-  
15       stituted a violation of the sections 7323 or 7324 of  
16       title 5, United States Code, or section 1341 of title  
17       31, United States Code.
